CHICAGO, IL --- The National Gang Crime Research Center (NGCRC) just announced plans for what promises to be the world's biggest and best gang training conference ever. The NGCRC is good at delivering on its promises. It has over 28 years of previous experience doing this kind of training for police, prosecution, corrections, and related criminal justice agencies.

"Actually, the NGCRC has a longer track record, our journal alone now has thirty-three years of previous publication", remarked Dr. George Knox, the executive director of the NGCRC, "this is our twenty-nineth continuous annual international training event, it is really a big event".

"Yes, of course, we do try to fill up the time schedule, if they are not learning in a formal way, we offer informal opportunities, and many different types of social networking events, like baseball or field training opportunities," Knox replied, "we do try to intentionally create a warm, positive learning atmosphere for our trainees".

"It is not just offering free tickets to evening baseball games, we simply try to make it an overall spectacular experience for people coming to Chicago, because for many of them, it is their first time in Chicago, and we like to go that extra mile to help them with whatever special interests they may have", Knox said.

Asked what is so special about classroom learning and evening entertainment, Knox said "we provide the best gang training, we develop the curriculum that others want to mimic or copy, we are able to do this because we are in this field, we are practitioners, researchers, and producers of knowledge about gangs, we lead the field, and this year, yes, we intend to roll out some new innovations, you will see things not available anywhere else because we helped produce the knowledge — and it gets released for the first time at our conferences."

"Nine Alleged Oakland Sure Zo Gang Members Charged With Racketeering Conspiracy In Connection With Murders And Related Crimes"

OAKLAND, CA - - - A federal grand jury has indicted nine men on charges of racketeering conspiracy in connection with two murders, three attempted murders, narcotics and firearms distribution, and other related crimes allegedly perpetrated on behalf of two

Oakland-based Sureño street gangs.

The nine defendants, Marvin Bonilla, a/k/a "Malandro," 24; Edwin Cano-Merida, aka "Zombie," 24; Cesar Rolando Lucas-Pablo, a/k/a "Lobo," 28; Walfer Mendoza-Mendoza, a/k/a "Shorty," 31; Gonzalo Pablo, a/k/a "Chalo," 25; Jeronimo Orlando" Pablo-Carrillo, a/k/a "Paisano," 41; Mario Pablo-Matias, a/k/a "Chuco," 24; Raymundo Pablo-Matias, a/k/a "El Mach," 21; and Carlos Barriro, Mardoza, a/k/a "Wingh," 28; ware abarged in an indict "El Moch," 31; and Carlos Ramiro-Mendoza, a/k/a "Minch," 28, were charged in an indictment filed October 9, 2025, and unsealed October 29.

Six of the nine defendants were arrested this morning in coordinated law enforcement operations. Lucas-Pablo and Pablo-Carrillo were already in custody, and Gonzalo Pablo remains at large. A number of the defendants are unlawfully residing in the United

Like people everywhere, the residents of Oakland deserve safe and peaceful neighborhoods, not ones filled with fear and senseless violence. The Administration has made it clear that enough is enough. This indictment charges nine members of the Oakland Sureños for their roles in a dangerous criminal enterprise that inflicted harm throughout Oakland," said United States Attorney Craig H. Missakian. "My office will continue to partner with local and federal law enforcement to reclaim our streets from the gangs who threaten our residents. We could not have done this case without the involvement of many law enforcement partners and, in particular, I would like to thank the FBI and the Oakland Police Department for their excellent work.

The alleged criminal activity of these gang members has plagued Oakland's neighborhoods and put innocent residents at risk," said FBI Acting Special Agent in Charge Matt Cobo. "The FBI remains steadfast in our commitment to prioritize violent crime and eradicate gang activity that threatens the safety and stability of our communities. While we continue to focus on disrupting the violent and illicit operations of local street gangs, today's arrests mark significant progress in that ongoing fight. The FBI and our law enforcement partners will not allow violent gangs to operate with impunity or endanger the citizens we are sworn to protect.

These individuals have caused lasting damage to our community for years," said Assistant Chief James Beere of the Oakland Police Department. "Their violent actions, including shootings and homicides, have left families mourning and communities forever changed. We are grateful for the efforts of our local law enforcement partners, the FBI, and the U.S. Attorney's Office, as we work together to seek justice for the victims and their families.

According to the indictment, the nine defendants were members of a racketeering enterprise referred to in the indictment as the Oakland Sureños, a criminal street gang whose members lived in and around Oakland, California. The Oakland Sureños were part of the larger Sureños criminal street gang and, like the larger Sureños gang, generally recognized the primacy of the Mexican Mafia prison gang. The larger Sureños gang was organized into "cliques," smaller groups that typically operated within specific territory.

In sum, each defendant is charged with one count of racketeering conspiracy, which carries a maximum statutory penalty of 20 years in prison and a \$250,000 fine. In addition, the indictment alleges that special sentencing factors apply to six defendants as follows:

The maximum statutory penalty applying to these violations is life in prison. Any sentence following conviction would be imposed by the court after consideration of the U.S. Sentencing Guidelines and the federal statute governing the imposition of a sentence, 18 U.S.C. § 3553.

SEATTLE, WA - - - A former U.S. Army Sergeant whose last duty post was Joint Base LewisMcChord (JBLM) in western Washington was sentenced in October in U.S. District Court in Seattle to four years in prison and three years of supervised release for two federal felonies, announced U.S. Attorney Charles Neil Floyd. "FBI Announces Major Violent Gang Takedown in Southeastern Wisconsin"

MILWAUKEE, WI - - - FBI Milwaukee announced on October 22 the results of "Operation Chalkline," a long-term multi-year criminal enterprise investigation that targeted a violent street gang

operating in Milwaukee and Racine with direct connections to a major international cartel.

FBI Milwaukee special agents and task force officers (TFOs) arrested 22 subjects on federal charges and executed 24 federal search warrants alongside local, state, and federal partners. The investigation resulted in the seizure of more than four kilograms of cocaine, 260 grams of fentanyl, 1.5 pounds of methamphetamines, six pounds of marijuana, 23 firearms, and three vehicles.

The investigation was led by a Mount Pleasant Police Department TFO as part of the FBI

Milwaukee Area Safe Streets Task Force, which included TFOs from the Caledonia Police Department, Mount Pleasant Police Department, Racine County Sheriff's Office, and Racine Police Department.

Additional local, state, and federal law enforcement partners assisted in the operation, which included the utilization of 14 SWAT teams. These partners included the Cudahy Police Department, Milwaukee County Sheriff's Office, Milwaukee Police Department, Oak Creek Police Department, West Allis Police Department, Wisconsin Department of Justice - Division of Criminal Investigation, Wisconsin State Patrol, ATF, DEA, FBI, HSI, and the U.S. Marshals Service.

FBI Milwaukee continues to prioritize crushing violent crime together with our law enforcement partners to ensure public safety and security in Milwaukee, Racine, and throughout the state of Wisconsin.

"Suspected Tren de Aragua Member Pleads Guilty to Illegal Firearms Possession"

ALBUQUERQUE – A Venezuelan national and suspected member of a transnational criminal organization has pleaded guilty in October to illegally possessing firearms and conspiring to destroy evidence after posting photos and videos of himself with weapons on social media.

According to court documents, Cristhian Ortega-Lopez, 23, a Venezuelan national, illegally entered the United States on December 15, 2023, and was released pending removal proceedings. In January 2025, Homeland Security Investigations received an anonymous tip that Ortega-Lopez, a suspected member of the Tren de Aragua transnational criminal organization and U.S.-designated Foreign Terrorist Organization, was living in Las Cruces and in possession of firearms.

Ortega-Lopez posted numerous photos and videos to his Facebook and TikTok accounts showing him handling, displaying, and shooting various firearms at a Las Cruces shooting range and other locations. On December 24, 2024, Ortega-Lopez posted photos and videos of himself at the residence of April Cano, a social media influencer and gun enthusiast, holding a rifle with tactical equipment while wearing a ballistic helmet with night vision goggles. In the videos, Ortega-Lopez referred to April Cano's parents, Nancy and Jose Cano, as "Patron" and "Patrona," and told an informant he had received a firearm as a Christmas gift from the Cano family.

Ortega-Lopez worked for the Cano family and received housing in return. Additionally, the Cano family took Ortega-Lopez to the shooting range to fire weapons and allowed him access to fire-

On February 28, 2025, agents executed search warrants and seized four firearms from April Cano's residence. During a post-Miranda interview, Ortega-Lopez admitted he recognized all four firearms and knew it was illegal for him to possess them. On April 20, 2025, Ortega-Lopez conspired with another person to destroy his Facebook account to avoid the contents being used against him at trial.

Nancy and Jose Cano were indicted this week on charges related to tampering with evidence. Nancy Cano faces charges of conspiracy to tamper with evidence, while Jose Cano is charged with both conspiracy to tamper with evidence and tampering with evidence. Both remain on conditions of release pending trial, which has not been scheduled.

"31 Defendants, Including Members and Associates of Organized Crime Families and National Basketball Association Coach Chauncey Billups, Charged in Schemes to Rig Illegal Poker Games"

BROOKLYN, NY - - - On October 23, at the federal courthouse in Brooklyn, a seven-count indictment was unsealed charging 31 defendants in criminal schemes to rig illegal poker games at various locations in New York City, East Hampton, New York, and throughout the United States. This morning, 31 defendants were arrested in 11 states, including members and associates of the Bonanno, Gambino, and Genovese organized crime families of La Cosa Nostra (LCN); Chauncey Billups, head coach of the Portland Trail Blazers of the National Basketball Association (NBA); and Damon Jones, also known as "Dee," a former NBA player with the Cleveland Cavaliers and Miami Heat. The defendants will make initial court appearances this afternoon at federal courthouses throughout the United States, including the Eastern District of New York.

Joseph Nocella, Jr., United States Attorney for the Eastern District of New York; Kash Patel, Director, Federal Bureau of Investigation (FBI); Christopher G. Raia, Assistant Director in Charge, FBI, New York Field Office (FBI); Ricky J. Patel, Special Agent in Charge, Homeland Security Investigations, New York (HSI); Jessica S. Tisch, Commissioner, New York City Police Department (NYPD); and Phoebe S. Sorial, Executive Director, New York Waterfront Commission, announced the arrests and charges.

'As alleged, members and associates of organized crime families fixed illegal poker games as part of a highly sophisticated and lucrative fraud scheme to cheat victims out of millions of dollars and conspired with others to perpetrate their frauds," stated United States Attorney Nocella. "Well-known former NBA players and former professional athletes, acted as 'Face Cards' to lure unsuspecting victims to high-stakes poker games, where they were then at the mercy of concealed technology, including rigged shuffling machines and specially designed contacts lenses and sunglasses to read the backs of playing cards, which ensured that the victims would lose big. The indictment and arrests sounds the final buzzer for these

Mr. Nocella also thanked Homeland Security Investigations Newark for their valuable contribution to the case.

"Today over 30 people were arrested and charged for their alleged roles in criminal schemes to rig illegal poker games to win large amounts of money. These individuals used technology and deceit to scam innocent victims out of millions of dollars – eventually funneling money to La Cosa Nostra and enriching one of the most notorious criminal networks in the world," stated FBI Director Patel. "This investigation spanned 9 states and FBI offices, and I want to thank the men and women of the FBI for their tremendous work and dedication rooting out those actors responsible. This FBI will never stop following the money to pursue and find those who break our laws.

"Using the allure of high-stakes winnings and the promise to play alongside wellknown professional athletes, these defendants allegedly defrauded unwitting victims out of tens of millions of dollars and established a financial pipeline to La Cosa Nostra," stated FBI Assistant Director in Charge Raia. "This alleged scheme wreaked havoc across the nation, exploiting the notoriety of some and the wallets of others to finance the Italian crime families. Our office maintains its aggressive pursuit of any Italian organized crime operating in our jurisdiction and will continue to stem all unlawful revenue streams fueling their illicit

"For years, these individuals allegedly hosted illegal poker games where they used sophisticated technology and enlisted current and former NBA players to cheat people out of millions of dollars," stated NYPD Commissioner Tisch. "This complex scheme was so far reaching that it included members from four of the organized crime families, and when people refused to pay because they were cheated, these defendants did what organized crime has hotel. In a typical legitimate poker game, a dealer uses a shuffling machine to shuffle the cards randomly before dealing them to all the players in a particular order. As set forth in the indictment, the rigged games used altered shuffling machines that contained hidden technology allowing the machines to read all the cards in the deck. Because the cards were always dealt in a particular order to the players at the table, the machines could determine which player would have the winning hand. This information was transmitted to an off-site member of the conspiracy, who then transmitted that information via cellphone back to a member of the conspiracy who was playing at the table, referred to as the "Quarterback" or "Driver." The Quarterback then secretly signaled this information (usually by prearranged signals like touching certain chips or other items on the table) to other co-conspirators playing at the table, who were also participants in the scheme. Collectively, the Quarterback and other players in on the scheme (i.e., the cheating team) used this information to win poker games against unwitting victims, who sometimes lost tens or hundreds of thousands of dollars at a time. The defendants used other cheating technology as well, such as a chip tray analyzer (essentially, a poker chip tray that also secretly read all cards using hidden cameras), an x-ray table that could read cards face down on the table, and special contact lenses or eyeglasses that could read pre-marked cards.

The defendants and their co-conspirators bet accordingly to ensure that the unsuspecting victims lost money. Through the rigged poker schemes, the defendants caused losses to victims of at least \$7 million.

As alleged, members of the conspiracy fulfilled different roles to ensure the schemes' success. The defendants Tony Goodson, Shane Hennen, Curtis Meeks, and Robert Stroud supplied the cheating technology. The defendants Ammar Awawdeh, Saul Becher, John Gallo, Zhen Hu, Stroud, and Seth Trustman organized the rigged games. Members of the cheating teams included the defendants Nelson Alvarez, Louis Apicella, Chauncey Billups, Eric Earnest, Marco Garzon, Jamie Gilet, Tony Goodson, Kenny Han, Hennen, Horatio Hu, Damon Jones, John Mazzola, Nicholas Minucci, Michael Renzulli, Angelo Ruggiero, Jr., Stroud, Trustman, and Sophia Wei. In addition, the defendant Anthony Shnayderman, among others, laundered the proceeds of the schemes. For example, game organizers sometimes directed victims to send money via bank wires to shell companies controlled by Shnayderman, who then transferred money (either in cash or cryptocurrency), less a money laundering fee, back to the game organizers.

As alleged in the indictment, the Bonanno, Genovese, and Gambino organized crime families of LCN backed the Lexington Avenue Game and the Washington Place Game and received a portion of the criminal proceeds from both the "straight" illegal poker games and rigged games run by the organizers of those games. In particular, Becher, Zhen Hu, and Trustman—the organizers of the Lexington Avenue Game—were required to make payments

to defendants Ernest Aiello, Julius Ziliani, and Thomas Gelardo of the Bonanno family for the games (rigged or "straight") that they operated. Similarly, Awawdeh and John Gallo-organizers of the Washington Place Game—were required to make payments to the defendants Lee Fama, Joseph Lanni, and Ruggiero of the Gambino family and to the defendant Matthew Daddino of the Genovese crime for the games (rigged or "straight") that they operated. For a period in 2023, the two games merged and were jointly operated. During that period, all three organized crime families received proceeds from the rigged and illegal poker games.

As charged in the indictment, members of the conspiracy committed violent acts, including assault, extortions, and robbery, in furtherance of the schemes to ensure the repayment of debts and continued success of the operation. Between November 2022 and February 2023, Gelardo, Zhen Hu and Ziliani extorted John Doe #5 to secure the repayment of a gambling debt. Among other things, Zhen Hu and Gelardo both punched the victim to get him to pay back the debt. In September 2023 and October 2023, Becher, Zhen Hu and Trustman extorted another victim by threatening him to pay back a debt from illegal poker games. On September 7, 2023, Awawdeh, Hoti, Mazzola, Minucci, and Stroud arranged and committed a gunpoint robbery of a co-conspirator to steal a rigged shuffler machine that the defendants wanted to use.

Bettors who were defrauded in the rigged games may be victims under the Mandatory Victims Restitution Act. If you believe you were a victim of the scheme, please contact 1-800-CALLFBI.

The charges in the indictments are allegations and the defendants are presumed innocent un-

less and until proven guilty.

The government's case is being handled by Office's Organized Crime and Gangs Section.

"Former Alabama Department of Corrections Officer Sentenced to Prison for Bribery"

HUNTSVILLE, AL - - - A former Alabama Department of Corrections Officer has been sentenced for bribery, announced U.S. Attorney Prim Escalona.

U.S. District Judge Liles C. Burke sentenced John Paul Ketteman, 28, of Huntsville, to 15 months in prison for receipt of a bribe by an agent of an organization receiving federal funds.

According to the plea agreement, Ketteman was employed as a corrections officer at the Ala-

bama Department of Correction's Limestone Correctional Facility in Harvest, Alabama. Ketteman's iob duties included inspecting prison cells for contraband and supervising inmates. In the Fall of 2022, ADOC's Law Enforcement Services Division began an investigation into contraband being smuggled into the Limestone Facility by corrections officers. As part of the investigation, Cash App records were obtained for Ketteman's account. These records revealed that in less than three months in 2022, Ketteman was paid more than \$10,000 to smuggle contraband into the Limestone Facility and to act as a lookout.

"Abdulrahman El Bahnasawy Committed" **Assault While Serving Sentence for Plot**ting a Terrorist Attack on New York City"

NEW YORK, NY - - - The U.S. Attorney's Office for the Middle District of Pennsylvania and the National Security Division of the Department of Justice announced in November that Abdulrahman El Bahnasawy, 27, of Ontario, Canada, pleaded guilty to offenses related to a 2020 attack on correctional officers at the United State Penitentiary Allenwood.

According to United States Attorney Brian D. Miller and Assistant Attorney General for National Security John A. Eisenberg, Bahnasawy was an inmate at USP Allenwood who, on December 7, 2020, attacked two corrections officers using a weapon made from part of a steel desk in his cell. Bahnasawy stabbed one officer in the head and face, and, when a second responded to assist, Bahnasawy stabbed her in the hand.

The first officer eventually lost his right eye as

a result of the attack. When Bahnasawy was restrained, a note was found in his sock that read, "This is a terrorist attack for the Islamic State." A pledge of allegiance to the Islamic State of Iraq and al-Sham (ISIS) was also found taped to the inside of a locker door in Bahnasawy's prison cell. Today, Bahnasawy pleaded guilty to multiple counts of assault, assault with intent to commit murder and possession of contraband inside a prison, as well as providing material support to ISIS, a designated foreign terrorist organization.

At the time of the attacks at USP Allenwood, Bahnasawy was serving a sentence for his role in plotting a mass-casualty terrorist attack in New York City on behalf of ISIS. Bahnasawy, a then-20-year-old Canadian citizen and resident, plotted with Talha Haroon and Russell Salic to conduct bombings and shootings in heavily populated areas of New York Čity during the Islamic holy month of Ramadhan in 2016, all in the name of ISIS.

An undercover FBI agent (UC) infiltrated the co-conspirators' terrorist plot, posing as an ISIS supporter prepared to join in the attacks. The FBI arrested Bahnasawy in May 2016 after he traveled from Canada to the New York City area in preparation for the attacks, and he has been in custody since that time.

This case was investigated by the Federal Bureau of Investigation. Assistant United States Attorney Geoffrey MacArthur and Counterterrorism Section Trial Attorney Jessica L. Joyce prosecuted this case.

The maximum penalty under federal law for these offenses is 130 years of imprisonment, a term of supervised release following imprisonment, and a fine.

A sentence following a finding of guilt is imposed by the Judge after consideration of the applicable federal sentencing statutes and the Federal Sentencing Guidelines.

"Arizona Leader of Violent Extremist Network '764' Charged with Running a Child Exploitation Enterprise, Supporting Terrorists, Producing and Distributing Child Pornography, and

PHOENIX, AZ - - - A federal grand jury in the District of Arizona in October returned a 29-count superseding indictment against Baron Cain Martin, known online as "Convict" (among other monikers), 21, of Tucson, Arizona. The superseding indictment charges Martin with participating in a child exploitation enterprise, conspiring to provide material support to terrorists, conspiring to kill, kidnap or main persons in a foreign country, producing child pornography (five counts), distributing child pornography (11 counts), coercing and enticing minors to engage in sexual activity (three counts), cyberstalking (three counts), animal crushing and distribution of animal crush videos, and conspiracy to commit wire fraud. Martin has been in federal custody since his arrest on federal charges on December 11, 2024.

'This man's alleged crimes are unthinkably deprayed and reflect the horrific danger of 764 — if convicted, he will face severe consequences as we work to dismantle this evil network," said

Attorney General Pamela Bondi. "I urge parents to remain vigilant about the threats their children face online."

"Martin is charged with conspiring to provide material support to terrorists, participating in a child exploitation enterprise, and producing child pornography, among many others," said FBI Director Patel. "His actions as a leader of this criminal network were so atrocious and extreme that he is charged with supporting terrorism. It's alleged that Martin not only committed these crimes but wrote and posted a guide for others to use to identify, groom, and extort their own victims. The FBI will not stop until we find those who perpetrate these horrific crimes that prey on the most vulnerable members of our communities."

"Martin stands accused of engaging in conduct specifically intended to inflict pain, spread fear, and destroy innocence," said Assistant Attorney General for National Security John A. Eisenberg. "His alleged actions targeting children as part of the 764 online terror network are so depraved they defy comprehension. We will use every available tool to protect our children and ensure that those who perpetrate such acts of pure evil face the full force of justice.'

The defendant's alleged actions in this case are an assault on the basic foundations of human decency," U.S. Attorney Timothy Courchaine stated. "While cowardly hiding his identity

"The defendant's alleged actions in this case are an assault on the basic foundations of human decency," U.S. Attorney Timothy Courchaine stated. "While cowardly hiding his identity behind a screen and a moniker, Mr. Martin preyed upon vulnerable victims while promoting some of the sickest forms of human depravity. It is an honor for the dedicated men and women of the U.S. Attorney's Office in the District of Arizona to fight against this nihilistic violence by bringing the full weight of American justice against its proponents."

According to court documents, Martin is a member and leader of "764," a criminal organization of Nihilistic Violent Extremists (NVEs) operating within the United States and abroad. Those involved with the 764 network methodically target vulnerable, underage populations by using social media to encourage the possession, production, and sharing of extreme gore media and child sexual abuse material (CSAM). Members of 764 seek to desensitize young people to violence and break down societal norms regarding violence. They normalize the possession, production, and sharing of explicit CSAM and gore material to corrupt and groom their victims toward future violence, gain notoriety among other members of the network, and spread fear for the purpose of accelerating chaos under the 764 ideology with an aim toward the disruption of society.

The superseding indictment alleges that, since approximately 2019, Martin, using his online moniker "Convict," has been a participant and administrator in 764 chatrooms, has coerced multiple victims into creating child pornography, extortion videos, and animal crushing videos. Martin also wrote a detailed guide that was posted online detailing how to identify, groom, and extort vulnerable juveniles, and advised readers to target victims struggling with mental health.

The superseding indictment accuses Martin of providing material support to terrorists by providing himself as personnel, services, and expert advice or assistance to carry out a conspiracy

The superseding indictment accuses Martin of providing material support to terrorists by providing himself as personnel, services, and expert advice or assistance to carry out a conspiracy to kill or maim a person in a foreign country. In furtherance of the conspiracy to provide material support, the superseding indictment alleges that in September 2022, Martin conspired with others to coerce and direct a victim living outside the United States to self-harm, self-maim, and self-kill.

In addition to the terrorism and conspiracy to kill or maim a person in a foreign country, the superseding indictment accuses Martin of using wire communications in a conspiracy to commit

murder-for-hire and of conspiring to commit wire fraud.

Martin is also accused of engaging in a child exploitation enterprise during which he produced and distributed child pornography. The superseding indictment also includes five separate counts of production of child pornography, eleven counts of distribution of child pornography, and three counts relating to the coercion and enticement of a minor to engage in sexual activity. In total, the superseding indictment alleges Martin victimized at least nine victims. Eight of Martin's victims were minors at the time he committed the offenses and their ages were between the ages of 11 and 15 years old.

Martin is alleged to have also engaged in animal crushing and of distributing animal crush videos to 764 members. He is accused of cyberstalking three separate victims, two of whom were

minors at the time of the offenses. If convicted, Martin faces a penalty of up to life in prison for each count that accuses him of participating in a child exploitation enterprise, conspiracy to kill, kidnap or maim persons in a foreign country, and coercion and enticement of a child; 30 years in prison for each count of production of child pornography, and 15 years for providing material support to terrorists; up to 20 years in prison for cyberstalking resulting in permanent disfigurement or bodily injury and wire fraud conspiracy; and 10 years in prison for cyberstalking a minor and use of interstate commerce facilities in the commission of murder-for-hire. Martin also faces mandatory minimum sentences of 20 years for the child exploitation enterprise, 15 years for production of child pornography, and 5 years for distribution of child pornography for each applicable count. Each offense also carries a fine of up to \$250,000 and up to a lifetime of supervised release. A federal district court judge will determine any sentence after considering the U.S. Sentencing Guidelines and other statutory factors.

"Six Alleged "Unknown Vice Lord Gang" Members Indicted for Attempted Murder in aid of Racketeering and Firearm Charges" MEMPHIS, TN --- A nine-count indictment was unsealed in the Western District of Tennessee charging six alleged members of a criminal street gang known as Unknown Vice Lords (UVL)

- Ghost Mob with conspiracy to commit murder, attempted murder, assault with a dangerous weapon, and firearms violations.

"As alleged, these individuals showed a blatant disregard for public safety, engaging in a retaliatory gang shooting in a residential neighborhood," said Acting Assistant Attorney General Matthew R. Galeotti of the Justice Department's Criminal Division. "Gang violence inflicts profound harm on our communities, fostering fear, destabilizing neighborhoods, and damaging the quality of life for law-abiding residents. The arrest of these violent gang members underscores the Justice Department's unwavering commitment to protecting public safety and the rule of law. We will continue to dismantle these criminal organizations and protect the safety and security of our citizens."

"The premeditated and horrendous acts of violence that these gang members committed demonstrates a blatant disregard for human life," said Special Agent in Charge Jamey VanVliet of the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Nashville Field Division. "The men and women of the ATF, along with our local, state, and federal law enforcement partners, remain committed to combatting violent crime and swiftly bringing these individuals to justice before they commit other senseless acts of violence."

According to court documents, the UVL Ghost Mob is a violent, criminal street gang that operates throughout the Western District of Tennessee and elsewhere. The UVL Ghost Mob is a subset of the Almighty Vice Lord Nation, which originated in Chicago and eventually spread to other parts of the United States, including Tennessee.

Court documents allege that on Sept. 6, 2020, after rival gang members opened fire on UVL Ghost Mob members and their families, injuring four people, UVL Ghost Mob leaders ordered a retaliatory attack. Shortly after midnight on Sept. 7, 2020, the defendants travelled to the residence of the rival gang members, armed with assault style rifles and wearing masks and gloves. The defendants intentionally shot approximately 40-50 bullets into the residence while the rival gang members were inside. Neighborhood security cameras captured the shooting. In the video, the defendants are depicted using, carrying, and firing multiple firearms into the residence.

The following defendants were charged for their role in the offense: Antwon Brown, also known as Yayo, 32 of Memphis, Tennessee; Cordera Douglas, also known as Chuckie Dee, 36 of Memphis, Tennessee; Willie Merriweather, 41 of Antioch, Tennessee; Tevin Richardson, also known as Santana, 34 of Memphis, Tennessee; Ricky Rogers, Jr., also known as Double R, RR, 32 of Memphis, Tennessee; and Laraveus Williams, also known as Ray Ray, 32 of Memphis, Tennessee.

Assault with a dangerous weapon in aid of racketeering carries a maximum penalty of 20 years' imprisonment. Conspiracy to commit murder and attempted murder in aid of racketeering

carries a maximum sentence of 10 years' imprisonment. The charge of discharging a firearm during and in relation to a crime of violence carries a mandatory sentence of at least 10 years consecutive to any other sentence. If convicted, a federal district judge will determine any sentence after considering the U.S. Sentencing Guidelines and other statutory factors.

The ATF and Memphis Police Department investigated the case.

According to court records, Liriano is a known member of the Bloods gang. In late December 2024, Liriano traveled into rival gang territory in order to confront rival gang members with a firearm. At the time, Liriano was on state probation for a 2023 felony firearm conviction in Lynn, in which he pointed a firearm in the face of a former girlfriend and threatened to kill her based upon his belief that she had associated with a rival gang member.

On Jan. 3, 2025, Liriano was observed entering a motor vehicle at a selector switch (also known as a machinegun conversion device) attached. Liriano was then placed under arrest. Based upon the presence of the selector switch, the firearm was capable of firing fully automatic and was therefore a machinegun. A subsequent search of Liriano's cellular phones revealed pictures of him in possession of other firearms.

"Two Russian Mob Leaders Sentenced To 25 Years In Prison For Murder-For-Hire Targeting A Journalist On Behalf Of The Iranian Government"

District of New York, John A. Eisenberg, the Assistant Attorney General for National Secu-Russo, Royse City, TX. One (1) hour rity, and Christopher G. Raia, the Assistant Director in Charge of the New York Field Office of the Federal Bureau of Investigation ("FBI"), announced on Oct. 30 that RAFAT AMIROV, a/k/a "Farkhaddin Mirzoev," a/k/a "P," a/k/a "Rome," and POLAD OMAROV, a/k/a "Araz Aliyev," a/k/a "Polad Qaqa," a/k/a "Haci Qaqa," were each sentenced yesterday to 25 years imprisonment for their participation in a murder-for-hier plot targeting Masih Alinejad, a journalist, author, and human rights activist, on behalf of the Government of Iran. In March 2025, Amirov and Omarov were found guilty of murder-for-hire, attempted murder in aid of racketeering, and related charges, following a two-week trial before U.S. District Judge Colleen McMahon, who imposed yesterday's sentences.

'The Government of Iran, a sponsor of terrorism, assassination, and espionage around the globe, brazenly brought its efforts to murder Masih Alinejad to New York," U.S. Attorney Jay Clayton said. "The plot exposed at trial involved actors on three continents, culminating with a hitman with an AK-47 outside Ms. Alinejad's apartment in Brooklyn. Yesterday's sentences send a clear message: the DOJ and our partners will expose and severely punish those who target U.S. citizens and bring terror to our community.

Assistant Attorney General John A. Eisenberg said: "The defendants and their criminal associates came chillingly close to gunning down an Iranian-American journalist on the streets of New York. Tehran has long sought to silence Ms. Alinejad, and after multiple failed kidnapping attempts, turned to Omarov and Amirov and their organization to stalk and murder her. This case is part of a well-documented and disturbing rise in plots involving criminal networks paid by Iran to target dissidents in the United States and around the world. We are committed to holding accountable those who join forces with this vile regime to violate our national sovereignty or threaten U.S. citizens.

FBI Assistant Director in Charge Christopher G. Raia said: "Rafat Amirov and Polad Omarov, two highly ranked members of the Russian Mob, attempted to assassinate Masih Alinejad to permanently silence her criticism of the Iranian government and public advocacy of human rights. These defendants operated as unlawful enforcers for a foreign government to target an American journalist on our nation's soil. May yesterday's sentencing emphasize the FBI's steadfast commitment to protecting Americans against any foreign actor seeking to inflict terror and physical harm to further a political agenda.

presented at trial:

AMIROV and OMAROV were high-ranking members of an Azerbaijani faction of the Russian Mob (the "Organization") who worked with other members of the Organization to kill Masih Alinejad on instructions from high-ranking members of the Islamic Revolutionary Guard Corps ("IRGC"). Ms. Alinejad has previously been the target of multiple plots by the Government of Iran to intimidate, harass, and kidnap her for her work as a journalist, author, and human rights activist who has publicized the Government of Iran's human rights abuses, especially its discriminatory and oppressive treatment of women, repression of political expression, and killings of Iranians engaged in peaceful protests against the regime. As recently as 2020 and 2021, Iranian intelligence officials and assets plotted to kidnap Ms. Alinejad from within the U.S. for rendition to Iran in an effort to silence her criticism of the Iranian regime.

IRGC turned to AMIROV—a Vor, or Thief-in-Law, the highest rank in the Russian Mob and OMAROV—the cousin of a powerful Vor who aspired to become a Vor himself—to locate, surveil, and murder her. The IRGC offered AMIROV \$500,000 for Ms. Alinejad's murder and provided him with targeting information about Ms. Alinejad, including her home address. Beginning in approximately July 2022, AMIROV sent this targeting information to OMAROV, OMAROV, in turn, communicated this information to Khalid Mehdiyev, another member of the Organization who had been residing in Yonkers, New York, so that Mehdiyev could surveil Ms. Alinejad and murder her. AMIROV and OMAROV arranged the delivery of \$30,000 to Mehdiyev from the IRGC's advance payment; Mehdiyev used a portion of these funds to buy an AK-47 style assault rifle, two magazines, and 66 rounds of ammuni-

In late July 2022, Mehdiyev repeatedly traveled to Ms. Alinejad's neighborhood to surveil her residence and locate her. Mehdiyev sent photographs, videos, and updates on his stakeouts to OMAROV, who passed them on to AMIROV. AMIROV gave OMAROV intelligence about Ms. Alinejad's home, location, and family members provided by his IRGC contacts to assist Mehdiyev's attempts to locate and kill Ms. Alinejad. On July 24, 2022, Mehdiyev reported to OMAROV from Ms. Alinejad's residence that he was "at the crime On July 27, 2022, OMAROV told AMIROV that Mehdiyev was ready to kill Ms. Alinejad, writing "this matter will be over today. I told them to make a birthday present for me. I pressured them, they will sleep there this night." On July 28, 2022, Mehdiyev sent OMAROV a video taken from inside the car that Mehdiyev was driving with the assault rifle and a message reading, "we are ready." As OMAROV continued to update AMIROV about Mehdiyev's readiness, AMIROV cautioned OMAROV, "let him keep the car clean." When Mehdiyev drove away from surveilling the residence on July 28, 2022, he was stopped after a traffic violation and, during a search of the vehicle, police officers found the assault rifle; 66 rounds of ammunition, including one in the chamber of the assault rifle; approximately \$1,100 in cash; gloves; and a black ski mask.

After Mehdiyev was arrested and placed into custody, OMAROV contacted Mehdiyev's mother and threatened to kill her and her other son if she did not locate Mehdiyev, in part because the IRGC was demanding the return of its money.

"Five MS-13 Members Found Guilty of Committing String of Six Grisly Murders to Advance Their Standing in the Criminal Street Gang"

LOS ANGELES, CA - - - Five members of the transnational criminal organization Mara Salvatrucha 13 (MS-13) were found guilty by a jury on November 10 of committing six murders to advance their standing in the gang – killings in which the victims varyingly were strangled, shot, stabbed with knives or a machete, beaten with a baseball bat, then, in some cases, had their bodies thrown off a cliff or down a hill in the Angeles National Forest.

At the conclusion of a nine-week trial, a jury found the following defendants guilty of one count of conspiracy to violate the Racketeer Influenced and Corrupt Organizations

Walter Chavez Larin, 26, of Panorama City; Roberto Alejandro Corado Ortiz, 30, of Baldwin Park; and Edwin Martinez, 28, of Cypress Park.

Chavez and Corado also were found guilty of two counts of violent crimes in aid of racketeering (VICAR) murder. Martinez was found guilty of three counts of VICAR murder. Bryan Alexander Rosales Arias, 28, of South Los Angeles, was found guilty of one trusting relationships with citizens. count of VICAR murder. Erick Eduardo Rosales Arias, 27, also of South Los Angeles and who is Bryan Rosales's brother, was found guilty of one count of VICAR murder.
"The horrific violence in this case underscores the urgency of destroying MS-13

and putting its depraved members behind bars," said United States Attorney General Pamela Bondi. "Under President Trump, MS-13 can no longer unleash terror on the American people with impunity. We will eradicate this foreign terrorist organization and secure justice for its victims

According to evidence presented at trial, the defendants murdered their victims who either were – or perceived to be – members of the 18th Street gang, a rival of MS-13, or had violated MS-13's rules.

The trial focused on MS-13 Los Angeles cliques that implemented gang rules that required its members to use murder and extreme violence to rise within its ranks.

The charges relate to machete, knife, and baseball bat killings in the Angeles Nacrimes committed in aid of racketeering (VICAR). Those six counts allege that the victims were killed "for the purpose of gaining entry to and maintaining and increasing position in MS-13 Los Angeles

In June 2017, one victim – who claimed he had a leadership role in MS-13– was taken to the Angeles National Forest then stabbed and hacked to death by his killers, including Chavez. Several of the assailants unsuccessfully tried to decapitate him then left his body behind.

In October 2017, another victim - rumored to be an 18th Street member - was lured to his death by two teenage girls. He was kidnapped, strangled, beaten with a baseball bat then fatally stabbed with a large hunting style knife. Before his body was thrown off a cliff in the Angeles National Forest. This victim's assailants included Corado and Bryan Rosales.

In July 2018, a third victim – also rumored to be an 18th Street member – was lured to Malibu hills under the auspices of smoking marijuana and drinking beer with several other people. While the victim stood at a scenic overlook, Corado shot him in the back of the head. Corado gave the gun to Erick Rosales, who shot the victim before passing the gun to other MS-13 members who took turns shooting him. This victim's body ultimately was thrown off the edge of a road down a hill.

Cumulative stress faced by gang investigators can be especially challenging: the demands of suppressing rising violent crime, managing informants, always targeting/interacting with society's worst, extra scrutiny from command and courts, deadlines and targets handed down from superiors, working in small units full of Type A personalities, etc. And then you are expected to go home to the family and instantly switch it off; to transition back to a 'normal' person. This session will provide investigators with knowledge of cumulative stress and healthy coping mechanisms aimed at helping them manage the emotional rollercoasters they ride every day and transition from work to home. Armed with this info, investigators can lead better, more productive lives both as officers and 'normal' people, as well as be prepared to recognize fellow investigators who may be suffering in silence.

> (17) "Gang Ethics 101 - Don't Shoot the Messenger", by Kenneth Davis, Graffiti/Gang Specialist & Private Investigator, Yonkers, NY. One (1) hour

This course addresses current trends challenging the modern-day gang specialist. It reviews current issues that affect how we apply apprehension, prosecution, prevention, intervention, restorative justice, and information management practices to gangs and gang members. There are many ethical issues in dealing with gangs and gang members, and it affects every stage of the process, from investigation to aftercare, even gang research itself. Should violence interrupter staff be required to "warn and protect" when they learn that gun violence is imminent? Should someone who joins a gang remain in a gang database for the rest of their life? Attend this session to learn about ethical guidelines for dealing with gangs and gang members and to share your own scenarios.

(26) "New Trends on Asian Gangs and Transnational Organized Crime Groups: Part 2", by Dr. John Z. Wang, Professor, Department of Criminal Justice, California State University Long Beach, Long Beach, CA. Four (4) hours

(36) "Procedural Justice: Can it Help Solve Violent Crime?", by Christopher M. Felton, Ph.D., Detective Sergeant, Fort Wayne Police Department, Fort Wayne, IN. Two (2) hours

Treating people with the tenets of procedural justice (fairness and respect, equality and neutrality in decision making, and making sure they have a voice) has been qualitatively proven to increase a citizen's level of cooperation with, as well as respect for, the police. This occurs both at the time of the instant contact and subsequently to the that initial interaction between a citizen and a police officer. Numerous cases have been documented where simply employing these tenets has led gand members and other violent offenders to not only cooperate and give information during a roadside stop, but in future interactions in different situations as well. In this session, Det. Sgt. Christopher Felton will discuss current research on Procedural Justice as well as the findings from his qualitative dissertation on the experiences and successes of officers actually employing procedural justice when attempting to build

It covers the history, dangers, and trends of illicit fentanyl, emphasizing its extreme lethality and impact on our communities. The presentation also dispels myths, recommends protective measures, and explores solutions. Ultimately, it's a call to action, highlighting that drug use is preventable and collective efforts can make a difference.

THE NGCRC ATTRACTS THOSE WITH AND WITHOUT PRIOR TRAINING ON GANGS

One statistical result from the evaluation forms completed by those attending the 2025 NGCRC training conference reveals the NGCRC attracts those with and without prior training in gangs. In the 2025 cohort some 60.4 percent indicated that they had not previously received any training about gangs. Thus, some 39.6 percent of those attending the NGCRC training conference indicated that they had in fact been previously trained on gangs.

So a little over half of the attendees in 2025 had no prior training on gangs.

Also, about two-thirds (66.8%) reported that this was the first time they have attended an NGCRC gang training conference.

FEW ARGUE WITH THE FACTS: THE NGCRC OFFERS MORE CHOICES THAN ANYONE ELSE

One very powerful statistical result from the evaluation forms completed by those attending the 2025 NGCRC Conference relates to the number of choices a person does or does not have in terms of different options for classes to Louisville, KY. attend. In some training programs there is no choice at all, or few or very limited choices. Some 91.7 percent of those attending the NGCRC 2025 conference reported that "compared to other gang conferences I have attended, the NGCRC had more choices for sessions"

OVERWHELMING MAJORITY REPORT "BEST GANG TRAINING EVER"

As a testament to the high quality of the training experience at the 2025 NGCRC training conference, another significant statistical result from the evaluation indicated an exceptionally high level of satisfaction with the training. Some 90.2 percent of those attending the conference reported that it was, "in my opinion, the best gang training event I have ever attended." Such high levels of praise from people all over the USA and abroad are indeed hard to achieve.

ALMOST EVERYONE WANTS TO COME BACK NEXT YEAR

Another measure of the validity of high levels of satisfaction among those attending the NGCRC"s 2025

conference is found in the results to the question measuring intention to "come back next year".

The evaluation instrument included the following question: "I would like to attend the 2025 NGCRC 28th International Gang Specialist Training Conference that the National Gang Crime Research Center is currently planning.

One of the new organizational features introduced in 2025 was allowing attendees to reserve a slot for next year's training conference. The evaluation also provided for whether or not, among those who want to come back in 2026, the NGCRC should "reserve me a slot for 2026". Some 73 percent wanted the NGCRC to reserve a slot for them

ACHIEVING NETWORKING: A GUARANTEED RESULT AT THE NGCRC CONFERENCE

Three separate evaluation questions addressed the issue of "networking" because this is always an important "added benefit" of any training, and tors Office, New Albany, IN. it becomes particularly valuable as a resource when dealing with gang problems.

The first question asked, "Did you meet any new gang specialists that you may be able to network with in the future while you were at this conference". The results of the evaluation question about whether the participants at the 2025 NGCRC training conference were able to achieve networking showed an astounding 94.1 percent reported that they were able to achieve such networking while at the conference.

The second question sought to establish a baseline for how important the factor of "networking" was to those attending the 2025 NGCRC conference. The second question therefore asked the participants "Was the opportunity to network with other gang specialists something that you wanted to achieve while at this conference?" Here we find that 97 percent indicated that networking was an important goal for them at the conference. Based on this, it is safe to say that a very high level of success was achieved recording the coal of retworking was the 2005 NGCRO. is safe to say that a very high level of success was achieved regarding the goal of networking at the 2025 NGCRC Training Conference.

A number of specialized "networking receptions" were available to anyone who wanted to participate in these events during after hours. These are well planned and well managed events designed to enhance networking among professionals. Thus, a third and final question about networking in the evaluation survey asked, "Did you attend any of the special networking receptions?" Here we find that about two-thirds, some 65.7 percent, attended one or more of these specialized reception events. There were five (5) different social networking receptions available free to attendees at the 2025 NGCRC training

VERY HIGH LEVELS OF SATISFACTION WITH THE QUALITY AND QUANTITY OF TAKE HOME TRAINING MATERIALS

The rating system used by the NGCRC to evaluate the performance of the trainers and presenters, as well as its own operations, utilizes a "scale of values from an absolute low value of "zero" to indicate the low extreme of "not satisfied" to an absolute high value of ten (10) to indicate the high extreme of "very satisfied". Thus, the "score" in such cases is easy to interpret: the higher the score, the higher the level of satisfaction.

The "mean score" is what is used to calculate an overall score for performance. The mean is the arithmetic mean, a measure of central tendency

in the data, and it is calculated by means of an SPSS analysis. SPSS is a statistical software package widely used in the social science es and crin The evaluation form included the following question measuring the quality of materials: "How satisfied were you with the quality of the take

home training materials provided to you?". Each participant is provided with a "take home goody bag" that contains various printed training materials for future use. The results indicated a mean score of 8.11 on a zero to 10 point scale.

A second question asked "How satisfied were you with the quantity of take home training materials provided to you?" And here again a very high score emerges, a mean value of 8.14 was found for this factor.

MANY WON SOMETHING IN ONE OF THE RAFFLES

There are various raffles at the NGCRC conference, some occur at the networking receptions and some are scheduled through the Operations

The evaluation form asked the conference participants, "Did you win anything in any of the raffles?" The results indicated that almost half of those who attended, or 62.1 percent of those attending the conference, reported winning something in one of the raffles.

JUST OVER HALF ATTENDED AN EVENING CHICAGO CUBS BASEBALL GAME

The exit survey question in the evaluation form ask the attendees "did you attend any of the Cubs Baseball Social Networking Events"? There were two such events, one for Monday, and one for Tuesday. The results from the Evaluation Form data analysis show that 57.9 percent indicated participating in this popular event.

HIGH LEVELS OF SATISFACTION WITH NGCRC STAFF

The evaluation form included the question "How satisfied were you with the staff and volunteers of the National Gang Crime Research Center in terms of making your experience at the training conference a quality time?". The results indicated a mean score of 8.78 on a scale between zero and ten, again a very high level of satisfaction with the NGCRC staff. The staff provide a number of useful functions to the conference participants, from security to equipment technician support. Scoring near or above a score of 9.04 on a zero to 10 scale is an "A" in anyone's book

CONFERENCE PARTICIPANTS GAVE "HIGH GRADES" TO THE NGCRC AS AN OVERALL EVALUA-TION RESULT

Finally, another question on the evaluation form asked the 2025 NGCRC conference participants to "Give us

evidence of a high level of satisfaction among persons who attended the conference. A GPA of 3.57 (where 4=A, 3=B 2=C,1=D,0=F) was the mean score from this analysis. Thus, conference attendees gave the NGCRC an overall grade of "A minus/B Plus" it would appear from the 2025 evaluation results: again, a remarkable achievement.

"The Release Larry Hoover File: An NGCRC Special Report"

CHICAGO, IL - - - The significance of this story is that it quite literally about the "Free Larry Hoover" and "Free Hoover" line of gangwear clothing that has a history of being sold on eBay and which many gang specialists have seen over the last 35 years. Wearing a Free Larry Hoover t-shirt, sweat shirt, hat, hoodie, or jeans is a fashion statement supporting the release of Larry Hoover. These items of clothing are easily found and sold through eBay, just type in "release Larry Hoover" into the eBay search bar to see a long list of online sellers who produce and distribute this type of gangwear. The belief system espoused by wearing this kind of clothing item is a sympathetic view of the Larry Hoover as the "Chairman of the Board" or leader and founder of the Gangster Disciple

This is a study of a collection letters sent to Illinois authorities by persons asking for Larry Hoover to be released once and for all.

The ten letters and one email written to the Illinois Prisoner Review Board, or the State of Illinois Governor, are the subject of the present analysis. An FOIA request was made to the Illinois Prisoner Review Board by the NGCRC on October 28, 2025. The information provided in response to the FOIA request revealed there were eleven letters on file in favor of the release of Larry Hoover, or providing executive elemency, or providing a pardon.

The one surprise here is that we found no letters in opposition to providing executive clemency to Larry Hoover. There were no letters were on file from the Chicago Police Department or any other City of Chicago, Cook County, State of Illinois, or federal agency that were sent to oppose the release of Larry Hoover. It is possible, of course, that such letters might be sent after November 14th, 2025, which was the cut-off date for when the information made available for analysis here. We have seen no such "against" letters in the information provided here.

Use of a FOIA Request to Identify Source Documents

The source documents here are letters that were typed or handwritten, or emails, sent on behalf or against the release of Larry Hoover and which came to the attention of the Illinois Prisoner Review Board. It is standard procedure to use a Freedom of Information Act (FOIA) request to the Illinois Prisoner Review Board in order to get copies of all of the written documents or statements made for or against an individual. This is required to get copies of the source documents used in the analysis here.

High Skill Level of the Transcription Typist

The transcription typing was completed by one person with a doctorate degree who also specializes in digital media and has had advanced training in digital forensics. The work was checked for validity by comparing transcription results word by word with the text that appeared in the original source document. The work entailed transcribing N = 11 letters or emailed documents in the custody of the Illinois Prisoner Review Board and transcribing these narrative documents strictly according to the rules of transcription.

We do not correct spelling errors for the author, we transcribe exactly the what is spelled in the source document the way it is spelled there. We do not make editorial corrections to the grammar and punctuation for the author, we transcribe their text exactly the way they typed it or printed it or wrote it cursively in their own writing. If there is no indentation in the original source document, no indentation will be added when it is transcribed here.

Use of and insertion of the "(sic)" marker in transcribed text which contains an error is standard editing in the rules of transcription here for the benefit of the reader of the transcription. In Figure 1, for example, the author correctly spells the word "Governor" in lines 1, 13, and 17 but spells it differently in line 21 ("Governer"). Where appropriate the editing code of "sic" is used to denote that it was an error in its original form as it appears exactly in the source document. One letter did not correctly spell Larry's last name (Figure 3) was another example.

There are also letters where the authors had difficulty correctly spelling the name of Governor Pritzker, so in that kind of instance the spelling error in its original way of being presented on the letter would in the transcription be followed by (sic). The eleven letters are presented in Figures 1 through 11 below.

The analysis of eleven source documents shows Larry Hoover is portrayed as worthy of expeditious positive consideration for executive elemency. Six of the letters were written by two persons - - - a college student in Mississippi and the head of a non-profit in Illinois. Two of the letters had their name or signature information redacted in the source document so that they become anonymous for the review here. In most cases, then the authorship of the letters is available to analyze as well, showing a multi-state level of concern and support for the granting of executive

The letter in Figure 4 appears to be the actual writing of Larry Hoover appealing directly to the Illinois Prisoner Review Board. It is most clearly the case he is asking the board in a respectful way to be released back to society. Figure 4 includes a letter purporting that Larry Hoover somehow took advantage of what scant educational opportunities he was afforded and still achieved a Master's Degree. We would love to know more about that topic but we have not been able to confirm anything like that. If we are talking about a Master's level university degree here it would have seemed vital to include that information in an appeal for executive clemency because it would represent an incredible kind of educational upgrade achievement by an inmate in prison custody.

One of the letters (Figure 11) claimed that the Gangster Disciples are not a threat. This is the view from a writer whose self description or occupation is that of being a career military person (Navy Intelligence). He says "I work for the Navy Intelligence and was working domestically on the streets for a year or two. This organization or gang he allegedly started isn't much of a threat." So the author gave a different point of view if you were thinking gangs like the Gangster Disciples were bad things, this letter said "They actually seemed to help some while I was working for the country. I was actually in the gang as a teenager for a year before I joined the U.S. Navy. It seems to have always centrally been Growth and Development ideology. Anyhow, I think Larry Hoover has done enough time for whatever wrongs he has done to society. I would like to petition for his release as a career military person."

This project examined the eleven letters sent to the Illinois Prisoner Review Board about he case of Larry Hoover. There were a couple surprises that surfaced. One of the surprises was that one of the letters made the assertion, not at all widely known and which has still not been verified, that Larry Hoover has achieved a Master's degree while in prison. We have not been able to confirm any of that claim. Also it was surprising to see a letter from a career military person show up as one of the letters in support of granting executive elemency.

Historically, in America, it is not uncommon for persons occupying the role of Governor to issue pardons near or about Christmas time each year. If asked to bet if Larry Hoover will be getting that kind of Christmas present this year, we would probably bet "no". But not because of the outpouring of letters from law enforcement agencies sent in opposition to Larry's release as that was not a factor here. Our prediction would be that any such release decision would be made shortly after Christmas, maybe in January, 2026.

GANG PROBLEM IN 2024? Assistant Director in Charge of the Federal Bureau of Investigation ("FBI"), Christopher G. Raia, and Commissioner of the New York City Police Department ("NYPD"), Jessica S. Tisch, announced that SAUL ARISMENDY DE LA CRUZ, a/k/a "Nene," a/k/a "Venom," pled guilty in September before U.S. Magistrate Judge Judith C. McCarthy to racketeering conspiracy in connection with his participation in a violent theft crew. As alleged, DE LA

Saul De La Cruz, a former NYPD detective, provided confidential law enforcement information—including updates in active investigations—to a ring of thieves in exchange for monetary kickbacks," said FBI Assistant Director in Charge Christopher G. Raia. "His actions violated his oath to protect this city by enabling criminals to continue wreaking havoc on our local residents and ultimately evade arrest. While the vast majority of NYPD officers uphold their sworn dedication to serve, the FBI will continue to hold accountable those who prioritize personal financial enrichment over their duty to others, especially to further the operations of illicit enterprises.

"The NYPD holds its officers to the highest standards, and it's an affront to our entire department when someone so blatantly violates them and abuses the public's trust," said NYPD Commissioner Jessica S. Tisch. "Saul De La Cruz's actions were not only highly illegal, but they put our officers at great risk and jeopardized our public safety work. We will continue to work with our partners in the FBI and U.S. Attorney's Office to root out any misconduct and ensure justice is always served."

As alleged in the Indictment and Superseding Indictments unsealed in White Plains federal court:[1]

DE LA CRUZ was one of a number of defendants charged for participation in a violent theft crew led by the fugitive DAGOBERTO SOTO-RAMIREZ, a/k/a "Pito".

Between 2017 and 2022, SOTO-RAMIREZ organized a crew that committed residential burglaries and home invasion robberies, repeatedly targeting small business owners. The majority of the targeted victims were Asian American. Armed with guns and other weapons, members of the crew stole money, jewelry, and other property from scores of homes in states across the country. Others took part in the crew's criminal scheme, which property from scores of homes in states across the country. Others took part in the crew's criminal scheme, which also included the use of false identification, bank fraud, and laundering theft proceeds. In addition, SOTO-RAMIREZ and other members of the conspiracy bribed DE LA CRUZ, first an officer and later a detective of the NYPD, who

helped members of the crew escape arrest.

DE LA CRUZ, 33, of Queens, New York, pled guilty to one count of racketeering conspiracy, which carries a maximum sentence of 20 years in prison.

"Trinitarios Gang Members Extradited from Honduras to Face Rico Charges Related to Four Murders"

BOSTON, MA - - - Two Honduran nationals have been extradited to the United States to face racketeering charges. Each defendant – both of whom are alleged members of the Trinitarios – is charged with participating in two murders. They are alleged to have been in the United States illegally at the time of the murders and fled to Honduras to avoid federal charges.

Elvis Trujillo, 27, and Yeferson Vallecillo Cambar, 23, were arrested in December 2024 in Honduras at the request of the United States and extradited to the United States yesterday. Trujillo and Cambar will appeared in federal court in Boston on September 25. Trujillo and Cambar were each indicted by a federal grand jury on one count of RICO Conspiracy.

Trujillo and Cambar are alleged to be members of the Trinitarios criminal enterprise, which is a transnational criminal organization with a large presence in Massachusetts communities. In February 2025, federal charges were unsealed against more than two dozen Trinitarios members as part of a multijurisdictional takedown. Those charges included specific allegations that the Trinitarios were responsible for over 10 murders taking place over the last decade. Trujillo is charged with allegedly participating in two of those murders. Cambar is charged with allegedly participating in two additional murders

According to the charging documents, the Trinitarios are a hierarchical criminal organization, with positions that are known to exist at the state and local chapter level, whose members adhere to a code of conduct. Enmanuel Paula-Cabral, a/k/a, "Nelfew," a/k/a "Gordo," "Manny," allegedly served as the State Supreme of the Trinitarios for Massachusetts, responsible for the entirety of the gang's criminal activities, coordination with other state leaders and communication with leadership of the Trinitarios in the Dominican Republic.

Trujillo is charged with participating in the murder of Juan Espinal in March 2017, and the murder of Mindy Tran in November 2017. The murder of Espinal is alleged in court documents to have been committed by Trujillo and another Trinitario member on the orders of Trinitario leadership. Trujillo and the other Trinitario member are alleged to have ambushed Espinal and fired at him as he walked past, then chased him down and fired more rounds killing him in the street. The murder of Mindy Tran is alleged in court documents to have been committed by Trujillo and another individual during an attempted robbery of Tran during a marijuana sale. Trujillo is alleged to have fired the shot that killed Tran.

According to court documents, Trujillo was in the United States illegally and is believed to have consented to removal to Honduras following his conviction in a separate shooting incident in order to avoid charges for his role in the murder of Tran

Cambar is charged with participating in the murders of Jandriel Heredia and Abraham Diaz in September 2023. According to the charging documents, the Trinitarios wrongly believed rival gang members were in attendance at a graduation party and conducted a drive-by shooting that killed Heredia and Diaz and wounded five other surviving victims. The Trinitarios targeted the party to retaliate for the recent death of a Trinitario gang member. Cambar is alleged to have assisted in procuring the vehicle used in the double murder and assisting in the concealment and destruction of evidence after the fact.

Cambar is believed to have fled to Honduras to avoid charges for his role in the September 2023 shooting. Cambar was present in the United States during this time without legal status and without inspection at a port of

The charge of conspiracy to conduct enterprise affairs through a pattern of racketeering activity (also known as "racketeering conspiracy" or "RICO conspiracy") provides for a sentence of up to life in prison, five years of supervised release and a fine of up to \$250,000. Sentences are imposed by a federal district court judge based upon the U.S. Sentencing Guidelines and statutes which govern the determination of a sentence in a criminal case.

"D.C. Inmate Gets an Additional 36 Months for Smuggling Contraband into Jail"

WASHINGTON, DC - - - Stefon Freshley, 29, of the District of Columbia, was sentenced on September 25 in U.S. District Court to 36 months in prison for his participation in a conspiracy to smuggle a knife, dangerous drugs including fentanyl, and cell phones into the Central Detention Facility (CDF) of the Department of Corrections while he was awaiting trial for his role in the shooting of a 14-year-old boy and his father, announced U.S. Attorney Jeanine Ferris Pirro.

Freshley pleaded guilty June 27, 2025, to conspiracy to commit an offense against the United States. In addition to the 36-

month prison sentence, Judge Timothy J. Kelly ordered Freshley to serve three years of supervised release. According to court documents, in March 2019, Freshley was awaiting trial in two separate assault with intent to kill cases.

He was being held in the maximum security units of the CDF where he was housed with other detainees from the Clay Terrace neighborhood that included co-defendants Marcel Vines and Darius Robertson.

The Clay Terrace detainees recruited a correctional officer to smuggle contraband into the jail. One of the smuggled containers was intercepted by DOC investigators and included a switchblade, an iPhone, an iPhone charger, eyeglasses, bundles of marijuana and tobacco, rolling papers, gambling dice, three sheets of paper that had been impregnated with a synthetic cannabinoid, and cigarettes. The correctional officer was put on administrative leave.

Freshley and the other Clay Terrace inmates recruited a new officer to smuggle goods into the CDF. Prior to a July 2024 smuggling incident, Freshley coordinated the delivery of two unlocked phones into the CDF. One of the phones was used in an apparent attempt to intimidate witnesses in Vines' murder trial. The post sparked increased courthouse security measures for Vines' trial.

On July 25, 2024, the Department of Corrections conducted two searches of the Clay Terrace inmate units for contraband. DOC staff found, among other things, 269 blue pills which tested positive for fentanyl; 60 cigarettes soaked in an unknown liquid, 255 suboxone strips, seven pieces of paper soaked in an unknown liquid substance, three cellphones; and cigarettes.

On Aug. 30, 2024, Freshley was sentenced to 90 months in prison for his role in the drive-by shooting of a 14-year-old boy and his father. Freshley was a passenger in a vehicle with two associates on Dec. 28, 2018, when one of the associates fired about 30 rounds into a moving SUV. The boy was shot nine times, including in the head, abdomen, chest, and back. The father sustained gunshot wounds to his leg and hand. Freshley and his associates fled the scene.

The sentence handed down today by Judge Kelly will be served consecutive with the previous 90-month sentence. This case was investigated by the DOC Office of Investigative Services, the Metropolitan Police Department, and the FBI Washington Field Office. It was prosecuted by Assistant U.S. Attorney Joshua Gold and Sarah Santiago.

WHAT CITY IN AMERICA HAS THE WORST GANG PROBLEM IN 2025?

This was an open-ended item on the 2025 NGCRC Evaluation Form completed by N = 143 respondents. Many just left the question blank or made comments such as "everyone has a gang problem", or "I don't know", "I am from Canada", etc. It is a belief or perception type of variable that allows us to compare the results with findings in previous years.

Mike Cronin, Chicago gang investigator, has died at 81"

Former Chicago police Supt. Phil Cline said Mike Cronin "was probably the best street cop I've ever met". Mike lost his left foot and part of his leg in 1968, when he was a Marine fighting in Vietnam. That would be something that kept most men off the rolls of the Chicago Police Department. But not Mike. Mike sought expeditious positive consideration using a superior mental attitude that allowed him to improvise, persevere and overcome.

He was a well known leader in the area of gang crime investigation. He worked for the Chicago Police Department from 1971 and retired as deputy chief of the department's Narcotics and Gang Investigation Section. He died Nov. 9 from natural causes, according to his family. He was 81.

As seen in Table 2, Chicago again wins this record for having the worst gang problem in America (47.9%), compared to 28.6 percent for Los Angeles, and a remarkable low perception of only 3.8 percent for New York City. Memphis moves up to position number three on the "worst gang city" chart with 6.2 percent of the gang specialist respondents indicating that Memphis now has the worst gang problem in America.

"Founder and CEO of Non-Profit for Re-Entry Support Services Indicted on Drug Distribution Charges"

BOSTON, MA - - - The founder and CEO of Adapt & Evolve LLC, a Boston-based non-profit organization that purports to provide community re-entry support services, has been arrested and charged for allegedly distributing cocaine base (crack cocaine). According to court filings, the defendant has an extensive track-record of drug trafficking and other criminal conduct – including engaging in sex trafficking activity as well as a prior federal conviction for drug

Javan Tooley, 36, of Dorchester and Brockton, Mass., was indicted on Sept. 18, 2025 by a federal grand jury for distribution of 28 grams or more of cocaine base. Tooley was arrested on Sept. 23, 2025 and, following an initial appearance in federal court in Boston, was ordered detained pending a hearing

scheduled for Sept. 26, 2025 at 11:30 a.m.
In 2010, Tooley was convicted in U.S. District Court in Boston of distribution of cocaine, following a hand-to-hand sale of crack cocaine to undercover law enforcement. He was subsequently sentenced to five years in prison, followed by five years of supervised release for the conviction. According to court filings, following his release from federal prison in or around 2015, Tooley violated of the terms of supervised release on at least five separate occasions. As a result, Tooley was sentenced to serve approximately 22 additional months of incarceration.

Additionally, according to court filings, Tooley allegedly targeted and gage in commercial sex for his financial benefit and to distribute controlled substances for him. It is alleged that Tooley targeted his victims with acts of violence and provided victims with access to drugs. It is also alleged that Tooley created a climate of fear among the victims by claiming that he had connections to law enforcement and other powerful and influential officials through his non-profit. Tooley also allegedly coordinated drug transactions using the non-profit's phone.

It is alleged that on Sept. 10 2025, Tooley distributed 100 grams of

crack cocaine near Fields Corner in Dorchester, just a short distance away from Tooley's non-profit Adapt & Evolve. Tooley is alleged to have distributed the drugs in his car, while a young child – approximately six or seven years old – was in the back seat.

Huge Brazilian Raid on Rio Gang Results "Lots of valuable information. Great classes.", Allen Vannoy, Correctional Officer, Muscogee County Sheriffs Office, Columin 117 Dead and 81 Arrested

the most recent large scale gang raid in Brazil resulted in 117 gang members dying of gunshot wounds during the process which also resulted in the arrests of 81 living but sometimes wounded persons.

This was a quasi-military operation in that it involved the use of helicopters and armored vehicles and active duty military personnel working with law enforcement officers.

The gang involved in this operation was the Red Command which operates in Rio de Janeiro. One of the areas hit by the gang raid was the Alemao favela. A favela in Brazil is a distressed shantytown neighborhood inhabited by poor people.

This was no small operation, it took a year to plan, and in fact many American tactical operations against gangs pale in comparison in terms of force strength size. In this recent gang busting operation in Brazil there were about 2,500 police and soldiers. Five of the police officers were killed in the operation.

Once the operation was underway the gang counter-attacked by using urban guerilla warfare tactics against the government. The gang members blocked roads in northern and southeastern Rio to shut down all traffic by commandeering 70 large mass transit buses which were then positioned on the roadway and then set on fire to create the road blocks and traffic blockades.

The immediate effect was that 46 schools across the two neighborhoods were closed, and the nearby Federal University of Rio de Janeiro canceled night classes, advising everyone to seek shelter.

"33 Members of Violent Kensington Drug Trafficking Or- "Individual Associated with the 5-9 Brims Gang Charged in Conganization Charged in 41-Count Indictment"

PHILADELPHIA, PA - - - United States Attorney David Metcalf announced in Weymouth Street Drug Trafficking Organization with conspiracy to distribute controlled substances and dozens of related offenses.

U.S. Attorney Metcalf discussed the case alongside FBI Director Kash Patel, FBI Philadelphia Special Agent in Charge Wayne Jacobs, and Philadelphia Police Commissioner Kevin Bethel, and assisting federal and state law enforcement partners.

The indictment alleges that, from about January 2016 through October 2025, the Weymouth Street Drug Trafficking Organization ("Weymouth DTO") distributed fentanyl, heroin, crack cocaine, and cocaine on the 3100 block of Weymouth Street, one of the most prolific drug blocks in the city, functioning as an open-air drug market where illegal narcotics and arrests. are sold every day and at all hours. While that block is the nucleus of the group's alleged activity, their area of operations has extended to include the corner of F Street and Clementine

Street, the corner of E Street and Wishart Street, and 3000 Potter Street.

The indictment further alleges that the Weymouth DTO uses violence to enforce its territory, including shootings, murder, and physical assaults. Members of the Weymouth DTO retaliate against witnesses that the DTO believes provide information to law enforcement and commit violent acts against members of rival drug trafficking organizations.

rales Nieves, aka "Flaco," 45, of Luquillo, Puerto Rico, who authorizes other members of the Weymouth DTO to sell drugs on his block in exchange for "rent." Morales Nieves helps

"Elijah Roy, a Bloods associate, allegedly participated" protect the members of the DTO through the threat of violent acts, performed either by himself or his associates, against others who have caused the Weymouth DTO harm or attempted to sell controlled substances in the DTO's territory.

The indictment alleges that Ramon Roman-Montanez, aka "Viejo," 40, of Philadelphia, is a leader of the Weymouth DTO and manages the street-level operations. He is responsible for organizing the drug shift schedule, which establishes roles and shifts for who in the Weymouth DTO will be responsible for selling drugs at what times and on what days, managing proceeds, and obtaining more controlled substances.

As alleged, Nancy Rios-Valentin, 33, also of Philadelphia, is another leader of the Weymouth DTO responsible for organizing the drug shift schedule, as well as managing and maintaining drug proceeds.

A list of all defendants and the charges against them is below.

Twenty-four defendants were arrested in coordinated operations today. Eight defen-

dants were already in state or federal custody, and one remains at large

"Arizona Man Sentenced to Six Years in Prison for Plot Targeting **Christian Churches**"

SACRAMENTO, CA - - - Zimnako Salah, 46, of Phoenix, Arizona, was sentenced on November 7 in the Eastern District of California to six years in prison

in connection with his plot targeting Christian churches.

In March 2025, a jury in Sacramento convicted Salah of strapping a backpack around the toilet of a Christian church in Roseville, with the intent to convey a hoax bomb threat and to obstruct the free exercise of religion of the congregants who worshipped there. The jury's verdict included a special finding that Salah targeted the church because of the religion of the people who worshipped there, making the

According to the evidence at trial, from September to November of 2023, Salah traveled to four Christian churches in Arizona, California, and Colorado, wearing black backpacks. At two of those churches, Salah planted those backpacks, placing congregants in fear that they contained bombs. At the other two churches, Salah was confronted by security before he got the chance to plant those backpacks.

While Salah had been making bomb threats by planting backpacks in Christian churches, he had been building a bomb capable of fitting in a backpack. During a search of his storage unit, an FBI Bomb Technician seized items that an FBI Bomb Expert testified at trial served as component parts of an improvised explosive device

A search of Salah's social media records revealed that he had consumed extremist propaganda online. Specifically, those records showed that Salah had searched for videos of "Infidels dying," and he had watched videos depicting ISIS terrorists murdering people. In a cellphone video taken days before the crimes of conviction, Defendant Salah declared, "America. We are going to destroy it."

"This sentencing sends a clear message: those who target people because of their faith will face the full force of federal law," said Assistant Attorney General the collection of taxes drug distribution, firearms transfers, and decisions about who held whet resists. PHILADELPHIA, PA - - United States Attorney David Metcalf announced in October an indictment against a violent drug trafficking organization operating in the Kensington section of Philadelphia. The indictment charges 33 alleged members of the 2025 shooting at Taste of the City Lounge in Brooklyn, New York, in which three individuals were murdered and an additional 10 were shot and injured. Specifically, Roy is charged with assault in-aidof racketeering and with being a felon in possession of ammunition. The defendant is an associate of

the 5-9 Brims, a subset of the Bloods street gang, operating in and around Brooklyn.

Roy was arrested on September 18, 2025 in North Carolina. He is scheduled to be arraigned on the complaint this afternoon before United States Magistrate Judge Peggy Kuo.

Joseph Nocella, Jr., United States Attorney for the Eastern District of New York, Christopher G. Raia, Assistant Director in Charge, Federal Bureau of Investigation, New York Field Office (FBI),

and Jessica S. Tisch, Commissioner, New York City Police Department (NYPD) announced the charges

"As alleged, the defendant and other associates of a violent gang unleashed gunfire in the middle of a crowded bar, creating a killing zone that, in a matter of seconds, left three people dead and 10 victims wounded," stated United States Attorney Nocella. "Such a flagrant disregard for human life will not go unpunished and this prosecution underscores the resolve of our Office and law enforcement to eradicate gangs in the district. It is my hope that this arrest will give some comfort to the victims' loved ones and the traumatized survivors of this heinous crime.

Roy was with other associates of the 5-9 Brims, including Marvin St. Louis, who died as a result of the shooting. Also present at the Lounge were individuals associated with the Folk Nation Gangster Disciples (or "GD"), a rival of the 5-9 Brims that operates in and around Brooklyn, New York, including Jamel Childs, another victim of the shooting. At approximately 3 a.m., associates of the 5-9 Brims began shooting at associates of GD, who returned fire. Roy then proceeded to shoot back towards where Childs and the group of GDs were standing. Within approximately six seconds, over 40 shots were discharged by the defendant and others into the crowded bar. As a result of the shooting three people died and ten were shot and injured.

'Multiple Members and Associates of Violent Rancho San Pedro Street Gang Arrested on Federal and State Charges of RICO and Other Viola-

LOS ANGELES, CA - - - Multiple federal and state arrest and search warrants were served in October by hundreds of law enforcement personnel targeting members and associates of one of the most active and violent gangs in the Los Angeles Harbor area, known as "Rancho San Pedro" (RSP).

A multi-year investigation by the FBI, the Los Angeles Police Department and U.S. Homeland Security Investigations led to the identification of numerous RSP subjects. RSP is known to be

Eight of fourteen individuals charged in a federal criminal complaint filed in U.S. District demanded from day one: not turf battles, not silos, but agencies standing shoulder-to-shoulder around a single mission: protecting the people of this city."

Court were taken into custody today, as well as five defendants who are facing state charges by the Los Angeles County District Attorney. In addition, nine federal search warrants and eight state search warrants were executed at various locations in the San Pedro area.

"Our Harbor Division investigators, working closely with the FBI and HSI, methodically built a case to expose those directing this criminal enterprise," said LAPD Chief of Police, Jim McDonnell. "This operation delivers a powerful message—we will use every tool available to protect our communities and bring violent offenders to justice.

The Rancho San Pedro Enterprise is a multi-generational gang with a current estimated membership of approximately 500 individuals who are divided into approximately six subsets or 'cliques," including two female cliques. RSP originated in the 1970s and claims the city of San Pedro as its territory. RSP operates under the control of Mexican Mafia members who are incarcerated in California state prisons, and RSP members make payments known as "taxes" to the Mexican Mafia in return for their protection. Gang members who violate RSP or Mexican Mafia rules are subject to "discipline" in the form of assault. Serious violations, including cooperation with law enforcement, may result in death, according to the complaint.

"Today's takedown highlights my office's commitment to making America safe by dismantling violent street gangs," said Acting United States Attorney Bill Essayli. "Together with our federal and local partners, we can make our communities safe for law-abiding citizens.

The federal complaint charges thirteen defendants for their roles in a Racketeer Influenced and Corrupt Organizations Conspiracy (RICO) and for Conspiracy to Possess with Intent to Distribute Controlled Substances. The complaint also charges a fourteenth defendant for being a Felon in Possession of a Firearm and Ammunition.

'These arrests prove the power of partnerships," said Los Angeles County District Attorney Nathan J. Hochman. "When law enforcement agencies collaborate, we are able to take violent offenders and illegal weapons off our streets. These arrests demonstrate our commitment to restoring safety

Others committed or conspired to commit acts of violence to preserve and expand RSP's criminal operations, as well as to enhance their own status within the gang. Others engaged in drug trafficking, robbery, and extortion to generate revenue for the enterprise or would illegally maintain firearms and ammunition. Still others would possess, use, and carry firearms—or direct others to—in order to commit and threaten acts of violence, including conspiracies to commit murder and assault.

This investigation and today's operation is just another example of how effective partnerships in policing make the communities that we serve safer," said HSI Los Angeles Special Agent in Charge Eddy Wang. "HSI and our federal, state, and local law enforcement partners are committed to targeting the most violent gangs in the Southland.'

Members of the conspiracy possessed with the intent to distribute controlled substances, including methamphetamine, fentanyl, heroin, cocaine, and phencyclidine ("PCP). The complaint, which is expected to be unsealed today, details specific allegations attributed to the defendants.

"Organized criminal enterprises cannot stand up to the power of good law enforcement work," said Attorney General Bonta. "When we work together, we get results: As a result of this collaborative investigation, we've taken illegal weapons and dangerous drugs like fentanyl and heroin off our streets and kept our Los Angeles communities safe from the threat of violence. I'm grateful for the hard work our Special Operations Unit and the tireless efforts of our local and federal law enforcement partners on this operation, together we are working to make California safer for all."

If convicted of the charges in the criminal complaint, most of the federal defendants face a

statutory maximum of life in prison.

This investigation was conducted by the FBI, the LAPD, HSI, and the California Department of Justice. Multiple tactical teams participated in today's operation, to include the LAPD, the Torrance Police Department, HSI's Special Response Team, FBI S.W.A.T. teams from Los Angeles, Las Vegas, Phoenix and San Diego, and the FBI's Hostage Rescue Team.

"49 Members of a Violent Gang Charged with Drug Trafficking and Firearms Violations in "Gang Leaders Convicted For Facilitating Nationwide Prison Gang La Nuestra Familia" Bayamón, Puerto Rico"

Puerto Rico returned an indictment charging 49 violent gang members from the municipality of Bayamón with conspiracy to possess with intent to distribute, possession and distribution of controlled substances, and firearms violations, announced W. Stephen Muldrow, United States Attorney for the District of Puerto Rico. This investigation was led by the Bureau of Alcohol, Tobacco, of Spokane, Washington, to 75 months in federal prison on money laundering and drug conspiracy Firearms and Explosives (ATF), the Puerto Rico Police Bayamón Strike Force, and the Drug Enforcement Administration (DEA), with the collaboration of the U.S. Marshals Service, the Bayamón Municipal Police, the Guaynabo Municipal Police, and Customs and Border Protection Air and Marine Operations (CBP AMO).

'Today is the anniversary of 9/11 – the deadliest terrorist attack on American soil that took nearly 3,000 innocent lives. After the attack, Americans came together in unity, resolve, and determination to confront those who sought to harm us. Today, we face another threat to our communities – one that comes to use from criminal cartels – now rightly designated as foreign terrorist organizations – flooding our streets with fentanyl, other deadly drugs, and violence. In recent years, overdose deaths, mostly from fentanyl, have averaged over 100,000 per year. Just as 9/11 demanded a national response, the toll of gang violence and drug trafficking in our communities demands action and unity," said U.S. Attorney Muldrow. "The Department of Justice and our law enforcement partners, including those who participated in this morning's operation, are responding and taking action to make our communities and our streets safer. The indictment alleges that from 2019 through the present, the defendants worked as part of a drug trafficking organization known as "Bin Laden Records" that distributed illegal drugs for significant financial gain and profit — including heroin, cocaine base (commonly known as "crack"), cocaine, marihuana, fentanyl, Oxycodone (commonly known as Percocet), and Alprazolam (commonly known as Xanax) – all within 1,000 feet of the Virgilio Dávila Public Housing Project (PHP), and within 1,000 feet of a public or private school and/or playground.

As part of the operations of the drug points, the defendants and co-conspirators would obstruct and delay the work of law enforcement agents by obstructing the main entrance of the Virgilio Dávila PHP with shopping carts.

The defendants acted in different roles to further the goals of the drug trafficking conspiracy, including acting as leaders, drug point owners, enforcers, runners, sellers, lookouts, and

"Puro Tango Blast Gang Member Sentenced to 20 Years in Federal Prison on Drug and Firearms Cases"

member was sentenced to 20 years in federal prison for drug and gun charges, announced Acting United States Attorney for the Northern District of Texas Nancy E. Larson.

In February 2025, Daniel Ortiz 34, of San Antonio, Texas, pled guilty to one count of conspiracy to distribute a controlled substance, one count of burglary involving controlled substances, and two counts of possession of a firearm by a convicted felon. Yesterday, he was sentenced to 240 months in federal prison by United States District Judge Karen Gren Scholer.

In court documents, Ortiz admitted that in January 2024, he and two codefendants burglarized a MedPlus Pharmacy located in San Antonio, Texas. On the morning of January 11, 2024, Ortiz and his codefendants used the Zello app on their cell phones to communicate before, during, and after the burglary. Zello is a cellular telephone application (app) that works as a secure push to talk radio using cellular networks and Wi-Fi. Ortiz admitted that on the morning of January 11, 2024, one of his codefendants made two false 911 calls with the intent to divert law $enforcement\ officers\ away\ from\ the\ MedPlus\ Pharmacy.\ Following\ the\ 911\ calls, Ortiz\ broke\ into$ the pharmacy and took quantities of codeine and other controlled substances (see photos below). Ortiz then transported the stolen drugs to the DFW area and attempted to sell them to customers.

Ortiz also admitted in court documents that on March 30, 2024, he was operating a stolen BMW X5 traveling with his girlfriend eastbound on Interstate 30 in the DFW area. Police officers attempted to conduct a traffic stop of the stolen BMW and Ortiz fled from the officers at a high rate of speed. During the pursuant, the stolen BMW driven by Ortiz struck two other vehicles as he attempted to flee from officers. Ortiz admitted that after initially alluding police officers, he exited the interstate, abandoned the stolen BMW in a residential area, and fled on foot. Ortiz admitted that when he exited the BMW, he was in possession of a Glock, model 44, .22 caliber handgun. Ortiz fled to a nearby neighborhood and unlawfully entered a residence and attempted to hide. Law enforcement agents surrounded the residence, and Ortiz surrendered after a four-hour standoff. Ortiz is a multi-convicted felon and a Puro Tango Blast (PTB) member. PTB is a violent prison gang made up primarily of Hispanic men from Texas cities.

The investigation was conducted by the Texas Department of Public Safety, the Dallas Police Department and the Bureau of Alcohol, Tobacco, Firearms, and Explosives. Assistant United States Attorneys Rick Calvert and Luis Suarez prosecuted the case.

To advance further, these children will "owe a body" to advance their lifelong "careers".

"These pervasive criminals intentionally seek out the next generation with the explicit goal of turning children into criminals (they call "soldiers") with full knowledge that these children will be part of the gang for the rest of their lives, and commit crimes both inside and outside of prisons across the Nation to further a bill-of-goods they've been sold," said Unit Chief Caitlin Baunsgard, the Assistant United States Attorney who handled this case. "The United States Attorney's Office for the Eastern District of Washington will not stand idly by and watch this happen. We have and will continue to work tirelessly with our law enforcement partners to investigate and prosecute

The court documents and information presented at the sentencing hearings in the case showed the following: Jacenir Amezcua DaSilva (gang name "Serio"); DaSilva is the leader of the Moses Lake Norteño set Pancho Villa Loco ("PVL"). In this leadership role, he passed along the radical teachings of NF and the importance of Norteño adherence to NF's "14 Bonds," which is The charging documents further allege that when the members of the gang perceived threats to the organization and/or its members, they incurred in violent acts, including, but not by NF leadership, a highly prestigious position within NF's hierarchy. As "the channel", DaSilva oversaw Norteño and NF interests over all the Norteño sets in his geographic area. He also facilitated any activities necessary to ensure the success of the continuation of the NF criminal enterprise, including moving money, hosting gang meetings, discussing matters of common interest with other Norteno sets, passing along messages to the "street," and participating in NF internal "investigations" into misconduct - that is, actions taken counter to the gang's interests. Incarcerated Norteños would also reach out to DaSilva to pass along messages of Norteño import, which would include directing activities in "the streets." In DaSilva's case, this included assisting in the issuance of a "kill on sight" order for an individual some members of NF believed to be an informant.

DaSilva was deeply vested in the continuation of the Norteño way of life. He ran Norteño Assistant U.S. Attorney (AUSA) and Chief of the Gang Section Alberto López-Rocafort; interests in Green Hill School, a juvenile detention facility that has become a "training ground" for the next generation of Norteno gang members whom the gang has indoctrinated into hardcore NF doctrines. Multiple witnesses identified the Green Hill School as "Gladiator School" because of its prosecution of the case. If convicted on the drug trafficking charges, the defendants face a mini-num sentence of 10 years to life in prison. If convicted of both the drug trafficking and the worthy NF gladiators. Some young Norteños have gone as far as committing new serious crimes with the specific intent to be sent to this juvenile facility.

Jesus Antonio Mirelez (gang name "Dizzy"). Mirelez was previously sentenced in federal court for his unlawful possession of two firearms and high-capacity magazines in 2022. Notably, one of the firearms Mirelez pled guilty to possessing in 2022 was linked by the National Integrated Ballistic Information Network ("NIBIN") — a national database that stores digital images of ballistic evidence, including fired bullets — to six separate shooting scenes in the Yakima Valley in 2022:

During the sentencing process in his 2022 case, he promised the Court he would not squander the opportunity to change his life. However, once he had served his 2022 sentence and was released on federal supervision, Mirelez continued his criminal conduct without pause. Only four months after being sentenced and promising change, he leaned into the radicalization of his Yakima-area Norteño gang set, La Raza ("LR"), and aligned them with the hard-core doctrine of NF. He was also appointed to a leadership position in LR – as the official "channel". His penchant for victimizing the community also conducted. A few months later, he was drunk and mistook a random citizen as a Sureño and attempted to harm the citizen and follow the citizen into his residence. When he was rebuffed, he shot several rounds in the direction of the citizen's residence. About a month later, Mirelez did the same thing again, resulting in a drive-by shooting that ended in On October 03, 2025, a confidential source provided information indicating a "hit" had him crashing his car. Both times, Mirelez ran from the police and threw away his firearms in locations where children could potentially find them, further endangering the community.

Mirelez also assisted NF members with paying their mandatory NF taxes on profits of their illicit ventures. He even enlisted his mother, Melissa Mirelez, to get word to the "streets" after his arrest about who he believed the informant in his case was - for the specific purpose of ensuring

that the individual would be killed. Thomas Lee Weatherwax (a/k/a "Wax"). > In his leadership role, Weatherwax oversaw "day-to-day" tasks within WSP, as well as managing overall responsibilities over all Norteños inside Washington's DOC programs. Like a first-line supervisor in a mainstream business, Weatherwax managed his team (Norteños in the

Delta Wing at WSP), and reported the team's work to his NF supervisor: As a leader in WSP, Weatherwax was responsible for accounting for the controlled substances present in WSP to distribute to other inmates as well as for an accounting of the money DALLAS, TX - - - A previously convicted felon who was a Puro Tango Blast gang owed to NF. In addition, Weatherwax and his RSD cohorts were also in charge of big picture operations of Norteños in all Washington DOC prisons, which included discipline decisions that had been blessed by NF leadership. For example, the RSD followed the directive to "remove" a Norteño named "Joker" from good standing in a Washington DOC facility based on his perceived rule transgressions. Weatherwax then reported the order being carried out by way of a "filter" (a small secretive writing) to NF management. Washington DOC confirmed that on March 19, 2024 'Joker" was beaten in prison by multiple Norteños until a non-lethal chemical irritant was deployed by guards. Overall, Weatherwax played a crucial role in the ongoing success of NF's continuing

criminal enterprise and ability to launder drug proceeds in furtherance of their criminal mission.

United States Attorney Pete Serrano commented on the extreme danger posed by these gang members, "even removing these predators from our communities and putting them behind bars has not been enough to stop them from engaging in ongoing violent crimes and victimizing our communities". Serrano highlighted the collaborative efforts of law enforcement to investigate this new NE threat and in ongoing violent crimes and victimizing our communities". I am here with a clear and unwavering message: ATF and our law enforcement partners will stop at nothing to bring them and every single

one of their co-conspirators to justice."

The holidays are always happier when you can shop at one internet shopping site and be able to buy thousands of different items to support your gang - - - or to help startup a new gang in your home town.

In today's modern world who cares if some of this stuff can get you killed just for wearing it in public where you might be seen by a rival gang. In fact, if you are not really in the gang and you wear it, you can be killed just as fast - - - because that is also a common cause of gang homicides: gangs call it "claiming", but they also call it "perpetrating" and persons caught doing it will suffer from imminent violence is what history

Why should anyone be concerned at all about this special ability that gangs and gang members have to spread their gang influence? After all, is it not a fact that everyone has a right to make a buck selling anything they can on Ebay? Who cares if it is gang-related? There is no specific law prohibiting the sale or distribution of gang paraphernalia, gangwear, gang artifacts, gang clothing, gang jewelry, or anything that carries and extols

For interactive training purposes, what you want to do here is select the first gang book t-shirt you see and click on the "seller's other items" navigation bar on the upper right side of the screen. And when there, type in the search bar "chicago gang" (without quotation marks). What you see now is the brilliant business model of this Ebay seller who provides free shipping from San Jose, California. This seller is just printing one page of the Chicago Gang Book one page at a time on t-shirts and selling them to all the gangs listed in that book or anyone else who wants to proudly wear their images.

What is the "Chicago Gang Book"? The version used in the printing of these t-shirts was published in 2018 by the Chicago Crime Commission. It was a popular gang identification guide. There was an earlier edition published in 2012 by the Chicago Crime Commission. The 2012 or first edition of the Chicago Gang Book was the subject of a lawsuit ("Suit: 'Gang Book' falsely labels man a gang leader", by Naomi Nix, July 25, 2012, Chicago Tribune). In the lawsuit, Edward Arroyo claimed that the Chicago Crime Commission's Gang Book falsely labeled him as a leader of the Spanish Gangster Disciples. The Crime Commission was simply publishing the information provided to them by survey respondents (e.g., local Chicago area police departments).

Here you see all kinds of different t-shirts, that are authentic in all details regarding gang identification. There are even items for the female gang members of the GD set - - - they are called SOS, Sisters of the Struggle, or Intellectual Sisters.

But what I want you to do, for interactive training purposes, is to hit the control and "F" keys simultaneously to bring up your search bar. Inside the search bar for this page type in "slippers". This will bring up some really cute Gangster Disciple Nation GD 74 Men's Indoor Slippers for only \$49.99 and you get free delivery. What GD gang member would not enjoy wearing these comfortable looking and stylish slippers adorned with GD gang slogans? Clearly, they are designed to look impressive and authoritative, and for only \$49.99.

Anyhow, the important thing here is note the name of this Ebay seller is "Bangland" and I want you to now click on the top right navigation bar for the seller's other items. Bangland offers convenient free shipping the contemporary of the contemporary of the contemporary of the contemporary of the search bar for the seller's other items. Bangland offers convenient free shipping the contemporary of the cont

of any of its wide array of contemporary American gang clothing items. It illustrates another type of Ebay entrepreneur: in this case the foreign actor, from Communist China, specifically Fujian - - - the coastal southeast province of China. So these are gang products which are produced and manufactured to look 100% authentic in China and shipped to buyers in American cities. Bangland is an Ebay seller that sells to a large number of gang identities not just the Gangster Disciples. There are authentic Vice Lord, Crips, Bloods, Surenos, Nortenos, Latin Kings, and other gangs that will enjoy the attractive gifts available here. Hoodies, tennis shoes, hats and caps, windbreakers, note books, all stylized with accurate gang identifying markings and symbols means this one site can be used to buy gifts for many

different large American gangs today.

Now for the third lesson to help you shop more effectively for gang members on your Christmas shopping list, let us look at the business model where the online Ebay store sells only items from one particular specific gang. For this exercise, go to www.ebay.com and in the search bar type the phrase "hells angels ball peen hammer pin". Now we see that this is a Hell's Angels merchandise only type of store. There are lots of items that you

can buy for Christmas gifts if you have any Hell's Angels on your shopping list. And these are all very affordable, generally speaking.

Finally, if you did have a Hell's Angels member or associate on your shopping list, say it was an in-law who is really an outlaw whom you really wish you did not have to get a gift for, not an uncommon shopping situation in the modern world we live in. "Leader of White Supremacist Group Pleads Guilty to Soliciting Hate Crimes and Sending Instructions to Make Bombs and Ricin"

BROOKLYN, NY - - - On November 17, at the federal courthouse in Brooklyn, Georgian national Michail Chkhikvishvili, also known as "Mishka," "Michael," "Commander Butcher," and "Butcher," pleaded guilty to soliciting hate crimes and sending instructions to make bombs and ricin. Chkhikvishvili was a leader of Maniac Murder Cult, an international racially motivated violent extremist group. Chkhikvishvili recruited people to commit violent acts in furtherance of Maniac Murder Cult's ideologies, including planning and soliciting a mass casualty attack in New York City. In May 2025, Chkhikvishvili was extradited from Moldova to the Eastern District of New York.

"The outstanding investigative work in this case saved untold lives and underscores the crucial behind-the-scenes activity of our federal law enforcement agents," said Attorney General Pamela Bondi. "Violent, nihilistic, racist groups like these are an ongoing threat to the American people – our vigilance will not waver as we protect our citizens."

With this guilty plea, this defendant admits to a horrific plot targeting Jewish people and racial minorities and even planned to poison children with candy around the holidays," said FBI Director Kash Patel. "The defendant was extradited from Moldova to face charges. This case shows once more that no matter where you are, if you try to harm our citizens the FBI and our partners will find you and bring you to justice.'

'Chkhikvishvili's monstrous plots and propaganda calling for racially motivated violence against civilians, including children, posed a grave threat to public safety," said Assistant Attorney General John A. Eisenberg. "Unfortunately, his efforts on behalf of the aptly named Maniac Murder Cult in fact caused mayhem and death. We condemn his despicable ideology and will use every tool at our disposal to bring such predators to justice."

"The defendant has admitted his vile actions, including recruiting others to commit acts of violence against Jewish and racial minority children. His incitement of hate crimes resulted in realworld violence," said U.S. Attorney Joseph Nocella, Jr. "This prosecution shows that our Office will protect all communities from evildoers like the defendant from wherever they spew their hate."

In June 2022, Chkhikvishvili traveled to Brooklyn, New York. Beginning as early as July 2022, Chkhikvishvili repeatedly encouraged others, primarily via the encrypted messaging application Telegram, to commit violent hate crimes and other acts of violence on behalf of Maniac Murder Cult. This included soliciting acts of mass violence in New York from an individual who,

unbeknownst to Chkhikvishvili, was an undercover FBI employee (the UC). Since approximately September 2021, Chkhikvishvili has distributed a manifesto titled the "Hater's Handbook" to Maniac Murder Cult members and others. The Hater's Handbook

encourages people to commit acts of mass violence. For example, the Hater's Handbook encourages its readers to commit school shootings. Beginning in approximately November 2023, Chkhikvishvili solicited the UC to commit violent crimes, such as bombings and arsons, for the purpose of harming racial minorities, Jewish individuals and others. In November 2023, Chkhikvishvili began planning a mass casualty attack in New York City to take place on New Year's Eve. The scheme involved having an individual dress up as Santa Claus and hand out candy laced with poison to racial minorities. In January, the scheme evolved and Chkhikvishvili specifically directed the UC to target the Jewish community, Jewish schools, and Jewish children in Brooklyn with poison. Chkhikvishvili sent detailed manuals about creating and mixing lethal poisons and gases, including ricin.

Chkhikvishvili's encouragement of violence have resulted in multiple attacks and killings around the world:

In January 2025, a 17-year-old student killed one individual and injured another before dying by suicide inside Antioch High School in Nashville, Tennessee. The attacker livestreamed part of the attack. Prior to the attack, in an audio recording posted online and attributed to him, the attacker claimed he was taking action on behalf of Maniac Murder Cult and at least one other group. The attacker's manifesto explicitly mentioned

In August 2024, an individual livestreamed himself stabbing approximately five people outside of a mosque in Eskisehir, Turkey, wearing a tactical vest bearing Nazi symbols. A manifesto attributed to the attacker included explicit references to Chkhikvishvili and to violent statements made by him. Before the attack, the attacker also distributed a link to the Hater's Handbook, authored by Chkhikvishvili, and other violent propaganda.

Chkhikvishvili faces a maximum sentence of 40 years in prison.

The FBI's New York Joint Terrorism Task Force investigated the case. The task force consists of investigators and analysts from the FBI, the New York City Police Department, and over 50 other federal, state, and local agencies, as well as the Department of State, U.S. Customs and Border Protection, the Justice Department's Office of International Affairs, and the government of Moldova for their crucial assistance in securing Chkhikvishvili's arrest and extradition.

The government's case is being handled by the Office's National Security and Cybercrime Section. Assistant United States Attorneys Ellen H. Sise and Andrew D. Reich are in charge of the prosecution, with assistance from Trial Attorney Justin Sher of the National Security Division's Counterterrorism Section and Paralegal Specialists Wayne Colon and Rebecca Roth.

"Omaha Gang Member Sentenced to 220 Months for Fentanyl and Firearm Crimes" OMAHA, NE - - - United States Attorney Lesley A. Woods announced that Clifford Wright III, 36, of Omaha, Nebraska, was sentenced on September 10, 2025, in federal court in Omaha

for possession with intent to distribute fentanyl, possession of a firearm in furtherance of a drug trafficking crime, and felon in possession of a firearm. Chief United States District Judge Robert F. Rossiter. Ir. sentenced Wright to a total of 197 months' imprisonment. There is no parole in the federal system. After Wright's release from prison, he will begin a 5-year term of supervised release Chief Judge Rossiter also sentenced Wright to a consecutive 23 months' imprisonment for violating his supervised release from a 2021 conviction for being a felon in possession of a firearm.

A jury convicted Wright of the three charges on June 6, 2025, after a seven-day trial. The evidence at trial established Wright, a documented member of the 29th Street Bloods in Omaha, who was observed on surveillance footage at a crowded gas station in north Omaha on October 31, 2022, making apparent hand-to-hand drug transactions from his vehicle. Shots erupted toward the crowded parking lot from across the street and Wright exited his vehicle holding a handgun, but his handgun appeared to malfunction or not fire.

Omaha police identified Wright based upon prior investigations and their knowledge of Wright as a gang member. Wright has two prior convictions in federal court for illegal firearm possession, including the conviction for which he was on supervised release at the time.

Wright was arrested on November 2, 2022. A search of a safe belonging to Wright pursuant to a warrant uncovered approximately 850 fentanyl pills and three loaded handguns, including a 9mm handgun that was visually consistent with the handgun Wright tried to fire at the gas station on October 31, 2022. The 9mm was the only handgun from the safe that had a round in the chamber. Two of the handguns had been reported stolen, including one stolen from the inventory of a federal firearms licensee in Omaha during a burglary.

Review of extracted data from Wright's cell phone showed that he had been dealing drugs dating back to February 2022, the month after he was most recently released from federal prison. Wright appeared to also be selling cocaine, ecstasy pills, and marijuana, based upon his text messages.

This case was investigated by the Omaha Police Department. An agent from the Bureau of Alcohol, Tobacco, Firearms and Explosives also testified as a firearms expert at trial. This case is part of Project Safe Neighborhoods (PSN), a program bringing together all levels of law enforcement and the communities they serve to reduce violent crime and gun violence, and to make our neighborhoods safer for everyone. On May 26, 2021, the department launched a violent crime reduction strategy strengthening PSN based on these core principles: fostering trust and legitimacy in our communities, supporting community-based organizations that help prevent violence from occurring in the first place, setting focused and strategic enforcement priorities, and measuring the

"Waterbury Gang Member Sentenced to Life in Federal Prison"

WATERBURY, CT - - - MALIK BAYON, also known as "Pop" and "Dirt," 29, was sentenced September 18 by U.S. District Judge Kari A. Dooley in Bridgeport to life in prison, and a

mandatory five-year consecutive term of imprisonment, for offenses related to his involvement in the 960 gang, a violent Waterbury street gang.

This announcement was made by David X. Sullivan, United States Attorney for the District of Connecticut; Maureen T. Platt, State's Attorney for the Waterbury Judicial District; P.J. O'Brien, Special Agent in Charge of the New Haven Division of the Federal Bureau of Investigation; Bryan DiGirolamo, Acting Special Agent in Charge, ATF Boston Field Division; and Waterbury Police Chief Fernando C. Spagnolo.

According to court documents and statements made in court, in an effort to address drug trafficking and related violence in Waterbury, the FBI, ATF, and Waterbury Police have been investigating multiple Waterbury-based groups, including the 960 gang. On September 14, 2021, a federal grand jury in Hartford returned a 36-count indictment charging Bayon and 15 other 960 gang members with various offenses, including racketeering, murder, attempted murder and assault, firearm possession, narcotics trafficking, and obstruction of justice offenses

According to the evidence presented during his trial:

On October 31, 2017, Bayon and other 960 members were involved in a drive-by shooting in the area of Porter Street and Bank Street in Waterbury in an attempt to murder members of a rival gang. An individual was shot and wounded in the shooting. Investigators recovered 17 shell easings from four different firearms at the scene.

On November 22, 2017, Bayon and 960 members Zaekwon McDaniel and Tahjay Love shot at Clarence Lewis and Antonio Santos who were in a car at a restaurant in Waterbury. Lewis sped from the scene at a high rate of speed and crashed into a house at the intersection of Wolcott Street and Dallas Avenue in Waterbury. Lewis, 22, and Santos, 20, were pronounced dead at the scene. Shell casings connected two of firearms used during the shooting to the shooting that occurred on October 31, 2017.

LOS ANGELES, CA - - - Five members and associates of the San Fernando Valley-based Vanowen Street Locos and Elmwood Rifa 13 gangs were arrested on September 30 on federal criminal complaints – four of them charged with taking part in a murder-for-hire plot targeting an Armenian Organized Crime boss but which instead resulted in his significant other getting shot and wounded in front of their two young children earlier this year.

The defendants arrested today are: Carlos Armando "Mary Oceans," of Van Nuys.

Also arrested on a complaint today was Vanowen Street Locos gang member Jose de Jesus Gonzalez, Jr., 49, a.k.a. "Listo," of Llano, who is separately charged in connection with the August 2023 shooting of Vahan Harutyunyan, 49, of Hollywood, Florida, who is now in federal custody on kidnapping and over 1,000 rounds of ammunition were seized during the search warrant services.

Grimaldi, Ayala, De La Cruz, and Mares are charged with use of interstate commerce facilities in the commission of murder-for-hire. Gonzalez is charged with conspiracy to violate the Racketeer Influenced and Corrupt Organizations (RICO)

The defendants are expected to make their initial appearances this afternoon in United States District Court in Los

According to affidavits filed with the complaints, Armenian Organized Crime, a Russian Mafia and Mexican Mafia-affiliated transnational criminal organization, has made Los Angeles County a center of its U.S. operations. Since 2022, two local leaders within the organization, also known as avtoritet, which in Russian means "authority," allegedly have engaged in a power struggle for control in their territory, resulting in mul-

tiple assaults, murder attempts, and a kidnapping.

Robert Amiryan, 47, of Hollywood, an avtoritet, has been the target of an assault and attempted murders ordered by a rival avtoritet, Ara Artuni, 41, of Porter Ranch. Amiryan and Artuni are in federal custody after being charged earlier this year with a series of crimes and are scheduled to go on trial in December 2025 and August 2026, respectively.

Artuni is principally charged with ordering the murder of Amiryan on multiple occasions in 2023. In retaliation, Amiryan conspired with members of his own criminal organization to kidnap and torture one of Artuni's associates in June

example, in February 2025, Ayala informed De La Cruz that he and others were still working "on th[e] job" to kill Amiryan.
On March 14, 2025, Grimaldi and Vahagn Stepanyan,

40, of Burbank, shot and wounded Amiryan's significant other as she arrived home in her car with their two children. Stepanyan is currently in federal custody and is charged with racketeering,

After the shooting, Mares called De La Cruz and reported that the "job [was] done," and Stepanyan would pay her \$50,000 for her role as the getaway driver, according to court documents. In the days afterward, Mares told De La Cruz, that she believed she would not be getting paid because "it was the wife not him." Stepanyan ultimately paid Mares a reduced rate because Amiryan was not killed.

A complaint contains allegations that a defendant has committed a crime. Every defendant is presumed to be innocent until and unless proven guilty beyond a reasonable doubt

If convicted, the defendants would face a statutory

Estrada and Abrante fired at least five rounds from a 9mm handgun into another vehicle in a drug trade dispute. "Today's guilty pleas by Joshua Estrada and Yancarlos Abrante are the result of a tireless and cooperative investigation by local, state and federal law enforcement," said Acting U.S. Attorney Craig M. Wolff. "The U.S. Attorney's Office and its partners are united in bringing to justice those who distrib-

'These two violent, dangerous men committed a brazen, drive-by shooting in Saco in broad daylight following a dispute over the cocaine they ton Division. "Their unabashed criminal behavior put innocent lives at risk, all so they could maintain their hold on their drug territory and keep the cash rolling in. This case underscores how the FBI's Southern Maine Gang Task Force and our law enforcement partners are working together to target and dismantle the violent drug gangs wreaking so much havoc in our communities, just to make money and a name for themselves on the street.

Estrada and Abrante face a mandatory minimum prison sentence of 20 years with a maximum of life, a fine of up to \$10 million, and not less than five years of supervised release. Both defendants will be sentenced after the completion of a presentence investigative report by the U.S. Probation Office. A federal district court judge will determine any sentence after considering the U.S. Sentencing Guidelines and other statutory factors.
